  - (a) Schedule 3.02 was amended by the deletion of all references to Aldin Avenue North, Diamond Road and Princes Street;
  - (b) Schedule 2.01 was amended by the addition of the wording in Schedule A hereto;
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
