 - (d) Schedule 3.03 was amended by the addition of the wording in Schedule C to this Order; and
 - (e) Schedule 4.10 was amended by the addition of the wording in Schedule D to this Order.
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

STATEMENT OF REASONS

This Order makes permanent the experimental 'No waiting at any time' restrictions introduced in December 2008 to prevent obstructive parking either side of the experimental road closure in Pitts Road and to improve sightlines outside No. 34 Pitts Road.

It also makes permanent the experimental single yellow line waiting restrictions operating between 8am and 6pm Monday to Saturday on the northern side of Pitts Road and the limited stay parking bay 'Maximum stay 2 hours no return within one hour' between 8am and 6pm Monday to Saturday introduced on the south side of Pitts Road outside the Church, also introduced in December 2008.

No objections to these restrictions have been received during the formal objection period. Following recent consultation with local residents and statutory consultees the Council intends to promote a Traffic Order to make the scheme permanent before expiration of the 18 month experimental period.
