**THE BOROUGH OF SLOUGH (AMENDMENT No. 12)
WAITING RESTRICTIONS AND RESIDENTS' PARKING (CONSOLIDATION)
ORDER 2010 ORDER 2012**

1. The Council of the Borough of Slough, in exercise of the powers conferred on it under Sections 1, 2, 4, 32, 35, 53 and 124 of Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, having particular regard to Section 122 and having consulted with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the Act hereby makes the following Order:-
2. This Order shall come into effect on the 30th April 2012 and may be cited as "The Borough of Slough Waiting Restrictions and Residents' Parking (Consolidation) Order 2010 (Amendment No. 12) Order 2012".
3. The Borough of Slough Waiting Restrictions and Residents' (Consolidation) Parking Order 2010 shall have effect as though :
 - (a) The wording set out in Schedule A to this Order is added as Schedule 1.10;
 - (b) The items relating to Bower Way, Dennis Way and Elmshott Lane Cippenham are deleted from Schedule 2.01 of this Order;
 - (c) Schedule 2.01 is amended by the addition of the wording set out in Schedule B to this Order;
 - (d) The wording set out in Schedule C to this Order is added as Schedule 3.22;
 - (e) The items relating to Elmshott Lane are deleted from Schedule 4.07 of this Order;
 - (f) Schedule 4.07 is amended by the addition of the wording set out in Schedule D to this Order;
 - (g) Schedule 13.03 is amended by the addition or the wording set out in Schedule E to this Order;
 - (h) Part III, Article 1 (1) of this order is amended by the addition of the wording detailed in Schedule F; hereunto;
 - (i) Part IV, Article 2 (1) of this order is amended by the addition of the wording detailed in Schedule G; hereunto
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
