 - (i) The following items in Schedule 5.01 were deleted, namely, those items relating to: Herschel Street; High Street (Slough); High Street (west) Slough; Montem Lane Lay-by fronting Montem Sports Centre; The Crescent Eastern Arm; and The Crescent Western Arm.
 - (ii) The items relating to The Crescent (Eastern Arm) and The Crescent (Western Arm) were deleted from Schedule 8.02, and replaced with the restrictions outlined in schedule A
- 4. This Order shall be known as the Borough of Slough (Amendment No.17) (Waiting Restrictions And Residents' Parking Order 2010) Order 2012.
- 5. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
