
## (VARIOUS ROADS, WOODSTOCK WARD, SOUTH GLOUCESTERSHIRE) (RESIDENTS' PARKING PLACES) (DISABLED PERSONS' PARKING PLACES) (PROHIBITION AND RESTRICTION OF WAITING) (VARIATION NO.1) ORDER 2021

The South Gloucestershire District Council (hereinafter referred to as "the Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as "the Act of 1984") and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following order:-

1. This order shall come into operation on the 22 July 2021 and may be cited as the South Gloucestershire Council (Various Roads, Woodstock Ward, South Gloucestershire) (Residents' Parking Places) (Disabled Persons' Parking Places) (Prohibition and Restriction of Waiting) (Variation No.1) Order 2021.
2. The South Gloucestershire Council (Various Roads, Woodstock Ward, South Gloucestershire) (Residents' Parking Places) (Disabled Persons' Parking Places) (Prohibition and Restriction of Waiting) Order 2019 is hereby varied and shall have effect as though:-
  - a) there were substituted for Schedule 1 thereto the Schedule numbered 1 as set out in Schedule 1 to this order; and
  - b) there were substituted for plan **T303-1164-26** annexed thereto plan **T303-1164-26 Rev A** annexed to this order.
