

THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA) (CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002) VARIATION ORDER (MILNTHORPE SQUARE) 2005

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

- 1. This Order shall come into operation on 28th February 2005 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) Variation Order (Milnthorpe Square) 2005
- For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
- 3. The 2002 Order shall have effect as though: -
 - (a) The following was added to Schedule 19 Parking Place Waiting Limited to 2 Hours, Return Prohibited within 2 Hours, 9.00 am 6.00 pm Full Week: -

- (f) The following were added as Articles 132A and 132B: -
 - 132A. Save as provided in Article 132B, no person shall cause or permit any vehicle to proceed in the lengths of road specified in Schedule 93A to this Order between the hours of 8.30 am and 4.30 pm on a Friday.
 - 132B. Nothing in Article 132A of this Order shall apply to: -
 - (i) vehicles being used for market trading purposes; or
 - (ii) vehicles carrying sick or injured animals.
- (g) The following was added as Schedule 93A: -

SCHEDULE 93A No Vehicles 8.30 am – 4.30 pm on a Friday Except for Market Traders

Milnthorpe	The Square	From its eastern junction with Main Street, the full length of its eastern, southern and western legs to its western junction with Main Street
Milnthorpe	Bull's Head Lane (running W-E between Beetham Road and The Square (south side))	From its junction with The Square to its junction with Beetham Road
Milnthorpe	Road located to the South of St Thomas' Church between The Square and Firs Road	From the eastern boundary of No.16 to its junction with The Square

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
