The County Council of Cumbria in exercise of its powers under Sections $1(1), 2(1)$ to (4), 19, $32,35,35 \mathrm{~A}, 38,45,46,47,49,51,53$ and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:
