

## THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA) (CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002) VARIATION ORDER (BURNESIDE ROAD AREA, KENDAL) 2006

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. This Order shall come into operation on 13<sup>th</sup> March 2006 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) Variation Order (Burneside Road Area, Kendal) 2006
- 2. For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
- 3. The 2002 Order shall have effect as though: -
  - (a) Article 2(46) was amended to read: -

"Zone A" means in relation to Kendal: -

Both sides of Caroline Street, both sides of Cross Street, 2 & 3 Green Close, 5 -27 Rydal Mount, 12-22 Rydal Mount, both sides of Union Street, 2-88 Burneside Road, 7-43 Burneside Road, 1-9 Windermere Road.

- (b) The entries in Schedule 8 Part 1 Kendal "Parking Place Restricted Waiting 8.00 am 10.00 pm Full Week, Waiting Limited to 30 Minutes, Return Prohibited within 30 Minutes" which relate to Burneside Road, Caroline Street and Cross Street, Kendal, were deleted in their entirety.
- (c) The entries in Schedule 30 Part 1 Kendal "Restricted Waiting 8.00 am 10.00 am Full Week, Waiting Limited to 30 Minutes, Return Prohibited within 30 Minutes" which relate to Union Street and Windermere Road, Kendal, were deleted in their entirety.
- (d) The following entries in Schedule 52 Part 1 Kendal "No Waiting At Any Time" were deleted in their entirety: -

Ashleigh Road NWAAT Both Sides From the centre of its junction with Burneside Road in a westerly direction for a distance of

From a point 41 metres south of the centre of its northern junction with Busher Walk in a northerly direction to a point 20 metres north of the centre of said junction

(e) The entry in Schedule 52 Part 1 Kendal "No Waiting At Any Time" which refers to Caroline Street (Northwest Leg) was amended to read: -

Caroline Street (Northwest Leg)

**NWAAT** 

Northeast

From the centre of its junction with Rydal Mount in a northwesterly direction for a distance of 10 metres

- (f) The following was added as Article 8A: -
  - 8A. Save as provided in Article 41, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a parking attendant, cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm, Monday to Friday inclusive, in any parking place specified in Schedule 4A:
    - (1) for a longer period than one hour; or
    - if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road.
- (g) Schedule 4A Part 1 Kendal "Parking Place, Restricted Waiting 8.00 am 6.00 pm, Mondays to Fridays, Waiting Limited to 1 Hour Return Prohibited Within 1 Hour" attached, was added as Schedule 4A thereto.
- (h) The entries in Schedule 5 Part 1 Kendal "Parking Place Restricted Waiting 8.00 am 10.00 pm Full Week, Waiting Limited to 1 Hour Return Prohibited Within 1 Hour" attached, were added to Schedule 5 thereto.
- (i) The heading to Schedule 5 Part 1 Kendal "Parking Place Restricted Waiting 8.00 am 10.00 am Full Week, Waiting Limited to 1 Hour Return Prohibited Within 1 Hour was amended to read: -
  - Schedule 5 Part 1 Kendal "Parking Place Restricted Waiting 8.00 am 10.00 pm Full Week, Waiting Limited to 1 Hour Return Prohibited Within 1 Hour"
- (j) The entries in Schedule 52 Part 1 Kendal "No Waiting At Any Time" attached, were added to Schedule 52 thereto.
