

THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA)  
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002) VARIATION ORDER  
(NEAR SAWREY, NEAR HAWKSHEAD) 2010

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and Part 6 of the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 8 March 2010 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) Variation Order (Near Sawrey, near Hawkshead) 2010
2. For the purposes of this Order the expression “the 2002 Order” shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 Order shall have effect as though:
  - (a) The following was added as Article 88(7) (A): -
 

between the hours of 10.00 am and 6.00 pm, from 1 March to 31 October inclusive, in the lengths of road or sides of road specified in Schedule 58A of this Order.
  - (b) The following was added as Schedule 58A: -
 

Schedule 58A Part 1 Miscellaneous “No Waiting, 10.00 am – 6.00 pm, 1 March to 31 October”:-

Near Sawrey	B5285	NW	South	From a point 50m east of the centre of its junction with Stones Lane (U5736) north-westerly for a distance of 9m.
Near Sawrey	B5285	NW	South	From a point 30m south-east of its junction with Stones Lane (U5736) extending in a north-westerly direction to a point 315m north-west of the said junction.
Near Sawrey	B5285	NW	North	From a point 29m east of the centre of Wilfin Beck Bridge, extending in a north-westerly direction for a distance of 127m.
Near Sawrey	B5285	NW	North	From a point 136m north-west of the centre of Wilfin Beck Bridge

				extending in a north-westerly direction to a point 115m south-east of the centre of its junction with Stones Lane (U5736)
Near Sawrey	B5285	NW	North	From a point 86m east of the centre of its junction with Stones Lane (U5736), extending in a north-westerly direction to a point 315m north-west of the centre of the said junction.
Near Sawrey	U5056	NW	Both	From the centre line of its junction with the B5285, extending in a southerly direction for a distance of 23m.
Near Sawrey	C5027	NW	Both	From the centre line of its junction with the B5285, extending in a southerly direction for a distance of 13m.

(b) The following entry in Schedule 58 “No Waiting, 10.00 am – 6.00 pm, Thursday Before Easter – 31 October”, was deleted in its entirety: -
