THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA) (CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002) VARIATION ORDER (MILNTHORPE) 2011

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

- 1. This Order shall come into operation on 14 March 2011 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) Variation Order (Milnthorpe) 2011
- 2. For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
- 3. The 2002 shall have effect as though: -
 - (a) The following was added as Article 86B: -
 - 86B. Save as provided in Article 87, no person shall, except upon the direction or with the permission of a Police Constable in uniform, cause or permit any vehicle to wait between the hours of 9.00 am and 6.00 pm, on a Monday to Saturday inclusive, in the lengths of road or sides of road specified in Schedule 51B: -
 - (a) for a longer period than two hours; or
 - (b) if a period of less than two hours has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road.
 - (b) The following was added as Schedule 51B "Restricted Waiting, 9.00 am 6.00 pm, Monday to Saturday inclusive, Waiting Limited to 2 Hours, Return Prohibited within 2 Hours": -
