# THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA) (CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002) (VARIOUS ROADS, KENDAL) VARIATION ORDER 2011

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. This Order shall come into operation on 28 March 2011 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) (Various Roads, Kendal) Variation Order 2011
- 2. For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
- 3. The 2002 Order shall have effect as though:
  - (a) The following entries were added to Schedule 52 Part 1 Kendal "No Waiting At Any Time"

- (2) A more restrictive 24 hour bus stop clearway (No stopping except local buses) will apply the bus lay by situated on the west side of Lound Road from a point 7m north of the north side of its junction with Garden Road southwards for a distance of 34m.

# **Amendment of Existing Order**

### Title of Order

The County of Cumbria (Central Area, Kendal) (Pedestrianisation and Traffic Regulation) Order 2005

#### Extent of Amendment

- (i) The following were added as Articles 17A and 17B: -
- 17A. Nothing in Article 17 shall render it unlawful for a person to ride or cause to be ridden a pedal cycle or tricycle in a northerly direction in the following lengths of road in the Pedestrian Zone:-
  - (a) Highgate, Kendal, between its junction with Allhallows Lane and its junction with Strickland-gate; and
  - (b) Stricklandgate, Kendal, between its junction with Highgate and its junction with Library Road.

PROVIDED ALWAYS that as far as possible cyclists should proceed on the carriageway and observe the normal traffic rule of keeping to the left.

- 17B. For the avoidance of doubt, cycling shall be permitted in Market Place, Branthwaite Brow and Finkle street providing that, as far as possible, cyclists follow the normal rule of the road of keeping to the left and the oneway traffic direction in Finkle Street.
- (ii) The following entry in Schedule 7"One-Way Traffic", was deleted: -

## PART 2A

### PROHIBITION OF DRIVING OF MOTOR VEHICLES

7A. No motor vehicle when proceeding in a northbound direction may enter that part of Highgate from its junction with the north side of Allhallows Lane northwards for a distance of 8m.
