THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA) (CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002) VARIATION ORDER (KENDAL) 2012

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

- This Order shall come into operation on 29 October 2012 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) Variation Order (Kendal) 2012
- 2. For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
- 3. The 2002 shall have effect as though: -
 - (a) The entry in Article 2 which relates to "Zone D in relation to Kendal", was replaced by the following: -

"Zone D in relation to Kendal means: -

Nos 2-82 (inclusive) and Nos 3-53 (inclusive) Natland Road, all of Rinkfield, all of Burland Grove and No. 41 Burton Road."

(b) The entry in Article 2 which relates to "Zone F in relation to Kendal", was replaced by the following: -

"Zone F in relation to Kendal means: -

Nos 1 – 6 Aynam Place, No. 78 Aynam Road, No. 2 Lound Road, all of Nether Street and all of Wilson Street."
