
THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA) (CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002) (KIRKBY LONSDALE) VARIATION ORDER 2013

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- This Order shall come into operation on 30 September 2013 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) (Kirkby Lonsdale) Variation Order 2013
- 2. For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
- 3. The 2002 Order shall have effect as though: -
 - (a) the following were added to Schedule 52 Part 5 Miscellaneous "No Waiting At Any Time": -

Kirkby Lonsdale	Lunefield Drive	NWAAT	West	From the north side of its junction with Lonsdale Rise in a southerly direction for a distance of 30m
Kirkby Lonsdale	Lunefield Drive	NWAAT	East	From the south side of its junction with Lonsdale Rise in a southerly direction for a distance of 34m
Kirkby Lonsdale	Lonsdale Rise	NWAAT	South	From the south side of its junction with Ruskin Drive in a easterly direction for a distance of 12m
Kirkby Lonsdale	Ruskin Drive	NWAAT	Both	From a point 25m north- east of its northern junction with Lonsdale Rise in a north-easterly direction for a distance of 10m
Kirkby Lonsdale	Ruskin Drive	NWAAT	North- western	From a point 9m south- west of its south-western junction with Lune Close in a north-easterly direction for a distance of 16m
Kirkby Lonsdale	Ruskin Drive	NWAAT	North- western	From a point 29m north west of its north-western junction with Lune Close in a westerly then northerly direction for a distance of 22m
