THE SOUTH TYNESIDE COUNCIL (CUSTOMS HOUSE) (VARIOUS CONSOLIDATION ORDERS NO.3) (VARIATION NO.2) ORDER 2007

The Council of the Borough of South Tyneside (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 3, 4 of The Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and by virtue of The Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of South Tyneside) Order 2006 and of all other enabling powers and after consultation with the Chief Constable of Northumbria Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

Commencement and Citation

 This Order shall come into operation on 10 December 2007 and may be cited as "The South Tyneside Council (Customs House)(Various Consolidation Orders No.3) (Variation No.2) Order 2007".

Amendments to The South Tyneside Council (Prohibition and Restriction of Waiting)(Consolidation) (No.3) Order 2007

- 2. The South Tyneside Council (Prohibition and Restriction of Waiting) (Consolidation) (No. 3) Order 2007 is amended as follows:
- 3. In Part IV the words in Articles 1, 2 and 3 are deleted and substituted by the following wording:-
- "1) No person shall cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm on Mondays to Saturdays in any length of road specified in Schedule 6.01 other than for the purpose of loading and unloading.
- 2) No person shall cause or permit any vehicle to wait at any time in any length of road specified in Schedule 6.02 other than for the purpose of loading and unloading.
- 3) No person shall cause or permit any vehicle to wait between the hours of 8.00 am and 5.00 pm on Monday to Fridays in any length of road specified in Schedule 6.03 other than for the purpose of loading or unloading".
- 4. In Schedule 1.01, Item number 78 relating to Daltons Lane South Shields, south side (ii) is revoked in its entirety.
- 5. In Schedule 1.01, after Item number 78 relating to Daltons Lane South Shields, south side (i) insert the following new rows:-
 - "(ii) from its junction with Brewery Lane in a northwesterly direction for a distance of 33 metres and including the cul-de-sac head;

- (iii) from a point 20 metres south east of its junction with Corporation Quay in a south easterly direction for a distance of 6.5 metres and including the cul-de-sac head"
- 6. In Schedule 1.01, after Item number 78 relating to Daltons Lane South Shields, the north side (ii) insert the following new rows:-
 - "(iii) from a point 24 metres south east of its junction with Corporation Quay in a southeasterly direction for a distance of 3 metres."
- 7. In Schedule 3.01, Item number 28 relating to Daltons Lane South Shields, south side (ii) is revoked in its entirety.
- 8. In Schedule 3.01, after Item number 28 relating to Daltons Lane South Shields, south side (i) insert the following new rows:-
 - "(ii) from its junction with Brewery Lane in a northwesterly direction for a distance of 33 metres and including the cul-de-sac head;
 - (iii) from a point 20 metres south east of its junction with Corporation Quay in a south easterly direction for a distance of 6.5 metres and including the cul-de-sac head"
- 9. In Schedule 3.01, after Item number 28 relating to Daltons Lane South Shields, the north side (ii) insert the following new rows:-
 - "(iii) from a point 24 metres south east of its junction with Corporation Quay in a southeasterly direction for a distance of 3 metres."
- 10. In Schedule 6.01, after Item number 6 relating to Daltons Lane South Shields, the north side (i) insert the following new row:-
 - "(ii) from a point 24 metres North West of its junction with Brewery Lane in a northwesterly direction for a distance of 9 metres."

Amendments to The South Tyneside Council (Movement Restrictions)(Consolidation) (No.3) Order 2007

- 11. The South Tyneside Council (Movement Restrictions) (Consolidation) (No. 3) Order 2007 is amended as follows:
- 12. In Schedule 36.01 after Item number 104, relating to Woodbine Street South Shields insert the following new row:-
 - " 105 Daltons Lane, South Shields from a point 27 metres east of its junction with Corporation Quay in a south easterly direction for a distance of 6 metres".
