THE SOUTH TYNESIDE COUNCIL (ST OSWALDS C OF E JMI SCHOOL, ST OSWALDS ROAD, HEBBURN)(NO STOPPING/KEEP CLEAR) ORDER 2007

The Council of the Borough of South Tyneside (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, and 2, 3 and 4 of The Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and by virtue of The Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of South Tyneside) Order 2006 and of all other enabling powers and after consultation with the Chief Constable of Northumbria Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

Commencement and Citation

1. This Order shall come into operation on 23 November 2007 and may be cited as "The South Tyneside Council (St Oswalds C of E JMI School, St Oswalds Road, Hebburn))(No Stopping/Keep Clear) Order 2007".

Amendments to The South Tyneside Council (Prohibition and Restriction of Waiting)(Consolidation) (No.3) Order 2007

- 2. The South Tyneside Council (Prohibition and Restriction of Waiting) (Consolidation) (No. 3) Order 2007 is amended as follows:
 - 3. In Schedule 8.02, after Item number 33 relating to McAnany Avenue South Shields insert the following new row:-
 - " 34. St Oswalds Road

North side

- from a point 30 metres west of the junction of Alwin Grange, in a westerly direction, for a distance of 27 metres:
- (ii) from a point 84 metres west of the junction of Alwin Grange, in a westerly direction, for a distance of 26 metres.
- 4. In Schedule 2.13, after Item number 14 relating to Rackly Way Whitburn insert the following new row:-

"15. St Oswald's Road Hebburn South side

- from its junction with the unnamed (i) access road to the front of No. 47 St Oswalds Road in a westerly direction for a distance of 7 metres;
- from its junction with the unnamed (ii) access road to the front on No. 47 St Oswald's Road in an easterly direction for a distance of 7 metres;

West Side

from its junction with the unnamed (i) access road to the front of No. 47 St Oswald's Road off St Oswalds Road in a

southerly direction for a distance of 9 metres;

East side

- (ii) from its junction with the unnamed access road to the front of No. 47 St Oswlad's Road off St Oswald's Road in a southerly direction for a distance of 7 metres.
- 5. In Schedule 4.06, after Item number 14 relating to Rackly Way Whitburn, insert the following new rows:-

"15 St Oswald's Road Hebburn South side

- (iii) from its junction with the unnamed access road to the front of No. 47 St Oswalds Road in a westerly direction for a distance of 7 metres:
- (iv) from its junction with the unnamed access road to the front on No. 47 St Oswald's Road in an easterly direction for a distance of 7 metres:

West Side

 from its junction with the unnamed access road to the front of No. 47 St Oswald's Road off St Oswalds Road in a southerly direction for a distance of 9 metres;

East side

(ii) from its junction with the unnamed access road to the front of No. 47 St Oswlad's Road off St Oswald's Road in a southerly direction for a distance of 7 metres.
