

**THE SOUTH TYNESIDE COUNCIL (TEMPLE PARK JUNIOR MIXED SCHOOL,  
MANET GARDENS, SOUTH SHIELDS))(NO STOPPING/KEEP CLEAR) ORDER  
2007**

The Council of the Borough of South Tyneside (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, and 2, 3 and 4 of The Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and by virtue of The Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of South Tyneside) Order 2006 and of all other enabling powers and after consultation with the Chief Constable of Northumbria Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

**Commencement and Citation**

1. This Order shall come into operation on 27 November 2007 and may be cited as "The South Tyneside Council (Temple Park Junior Mixed School, Manet Gardens South Shields))(No Stopping/Keep Clear) Order 2007".

**Amendments to The South Tyneside Council (Prohibition and Restriction of Waiting)(Consolidation) (No.3) Order 2007**

2. The South Tyneside Council (Prohibition and Restriction of Waiting) (Consolidation) (No. 3) Order 2007 is amended as follows:

3. In Schedule 8.02, after Item number 34 relating to St Oswald's Road Hebburn insert the following new row:-

" 35. Manet Gardens  
Temple Park Mixed Junior School

North side (i) from a point 42 metres west of the  
junction with Whistler Gardens, in a northerly  
westerly direction, for a distance of 22 metres;

(ii) from a point 135 metres west of the junction  
with Whistler Gardens, in a north westerly  
direction, for a distance of 22 metres."

4. In Schedule 2.13, after Item number 15 relating to St Oswald's Road Hebburn insert the following new rows:-

"16. Manet Gardens  
Temple Park Mixed Junior School

South side

(i) from its junction with Lawrence Avenue  
in a north westerly direction for a  
distance of 5 metres;

(ii) from its junction with Lawrence Avenue  
in a south easterly direction for a  
distance of 8 metres.

Temple Park Mixed Junior School  
West side

(i) from its junction with Manet Gardens in a south westerly direction for a distance of 5 metres;

East side (i) from its junction with Manet Gardens in a south westerly direction for a distance of 5 metres."

5. In Schedule 4.06, after Item number 15 relating to St Oswald's Road Hebburn, insert the following new rows:-

"16. Manet Gardens  
Temple Park Mixed Junior School

South side

(i) from its junction with Lawrence Avenue in a north westerly direction for a distance of 5 metres;

(ii) from its junction with Lawrence Avenue in a south easterly direction for a distance of 8 metres.

17 Lawrence Avenue  
Temple Park Mixed Junior School  
West side

(i) from its junction with Manet Gardens in a south westerly direction for a distance of 5 metres;

East side (i) from its junction with Manet Gardens in a south westerly direction for a distance of 5 metres."
