THE SOUTH TYNESIDE COUNCIL (RACKLY WAY WHITBURN) (PROHIBITION OF WAITING AND LOADING) ORDER 2007

The Council of the Borough of South Tyneside (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 3, 4 of The Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and by virtue of The Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of South Tyneside) Order 2006 and of all other enabling powers and after consultation with the Chief Constable of Northumbria Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

Commencement and Citation

1. This Order shall come into operation on 16 November 2007 and may be cited as "The South Tyneside Council (Rackly Way Whitburn)(Prohibition of Waiting and Loading) Order 2007".

Amendments to The South Tyneside Council (Prohibition and Restriction of Waiting)(Consolidation) (No.3) Order 2007

- 2. The South Tyneside Council (Prohibition and Restriction of Waiting) (Consolidation) (No. 3) Order 2007 is amended as follows:
- 3. In Schedule 2.01, Item number 37 relating to Rackly Way, Whitburn, both sides (i) is revoked in its entirety.
- 4. In Schedule 1.01, after Item number 387 relating to Oyston Street Carpark insert the following new rows:-

"388 Rackly Way Whitburn north side

(i) from its junction with East Street in an easterly direction for a distance of 17 metres to its junctions with East Back East Street (West Side)

south side

- (i) from its junction with East Street in an easterly direction for a distance of 15.5 metres to its junctions with East Back East Street (West Side)"
- 5. In Schedule 2.13 after, Item number 13 relating to Wood Terrace Bedeburn Primary School Jarrow, south side (i) insert the following new row:-
 - "14. Rackly Way Whitburn north side (i) from its junction with West Back Adolphus Street in an easterly direction

to its junction with Holly Avenue for a distance of 50 metres"

- 6. In Schedule 4.06, after Item number 13 relating to Wood Terrace Bedeburn Primary School Jarrow, south side (i) insert the following new row:-
 - "14. Rackly Way Whitburn, north side
 - (i) from its junction with West Back Adolphus Street in an easterly direction to its junction with Holly Avenue for a distance of 50 metres"
