

THE SOUTH TYNESIDE COUNCIL (MOVEMENT RESTRICTIONS) (CONSOLIDATION) (NO. 3) ORDER 2007

The Council of the Borough of South Tyneside (hereinafter referred to as "the Council") in exercise of the powers under Sections 1, 2(1) to (3), 4(2), 82(2), 83(2), 84(1) and (2), and Part V of Schedule 9 of the Road Traffic Regulation Act 1984 ("The 1984 Act") and under the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of South Tyneside) Order 2006 and by virtue of The Bus Lane Contraventions (Approved Local Authorities) (England)(Amendment) (No.7) Order 2006 and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following order:-

PART I

Commencement and Citation

- 1) This Order shall come into operation on the 3 August 2007 and may be cited as THE SOUTH TYNESIDE COUNCIL (MOVEMENT RESTRICTIONS) (CONSOLIDATION) (NO. 3) ORDER 2007

Revocation of Existing Orders

- 2) The Orders set out in the Schedule of Revocations to this Order are hereby revoked insofar as they relate to any of the items listed in the Schedules to this Order.

Construction and Interpretation

- 3) The Interpretation Act of 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 4) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulation made or having effect as if made under the Road Traffic Act 1984 (as amended) or by or under any other enactment.
- 5) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 6) For the purposes of this Order, a vehicle shall be taken to stop on a bus stop or bus stand if:-
 - a) Any point in the area comprising the stop or stand is below the vehicle or its load (if any); and
 - b) The vehicle is stationary.
- 7) In this Order, (except where the context otherwise requires), the following expressions have the meanings hereby respectively assigned to them:-

"Bus Lane Contravention" has the same meaning as in Section 144(4) of the Transport Act 2000;

“Carriageway” means a way constituting or comprised in a highway being a way (other than a cycle track) over which the public have a right of way for the passage of vehicles;

“Main Carriageway” in relation to any road or carriageway means any carriageway of that road or any part of that carriageway constructed or adapted for the passage of vehicular traffic but excludes any lay-by;

“Disabled Person’s Badge” has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 2000 (as amended);

“Disabled Person’s Vehicle” means a vehicle displaying a Disabled Person’s Badge;

“Goods” includes postal packets of any description and “delivering” or collecting” in relation to any goods includes checking the goods for the purpose of their delivery or collection;

“Goods Vehicle” means a motor vehicle not exceeding 30cwt unladen weight which is constructed or adapted for use for the carriage of goods of any description and is not drawing a trailer;

“Lay-by” means any area of carriageway intended for the waiting of vehicles and bounded partly by a traffic sign of the type shown in Diagram 1010 in Schedule 2 to the Traffic Signs Regulations and General Directions 2002, and partly by the outer edge of that carriageway on the same side of the road as that on which the sign is placed;

“Licensed Hackney Carriage” means a vehicle licensed by a Local Authority to operate as a taxi as defined in Section 4 of The Traffic Signs Regulations and General Directions 2002;

“Motor Car, Motor Cycle and Invalid Carriage have the same meaning respectively as in Section 136 of the Act of 1984;

“Parking Attendant” means a person authorized by or on behalf of the Council under Section 63A of the Act to supervise and enforce the restrictions imposed by Part IX and Part X, Section C of this Order

“Parking Place” means any area of carriageway authorised to be used as a parking place.

“Penalty Charge” for the purposes of Part VIII of this Order means a charge set by the Council under the provisions of Regulation 4 of The Bus Lane Contraventions (Penalty Charges, Adjudication and Enforcement)(England)Regulations 2005 (“the 2005 Regulations”) which is to be paid in a manner described in the penalty charge notice within 28 days of the date of the notice;

“Penalty Charge” and “Reduced Penalty Charge” for the purposes of Part IX and Part X, Section C of this Order mean a charge set by the Council under the provisions of Section 74 of the Road Traffic Act 1991 as applied and modified by the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of South Tyneside) Order 2006 in accordance with guidance given by the Secretary of State for Transport which is to be paid in the manner described in the penalty charge notice within 28 days of the date of the notice or 14 days of the date of the notice in the case of a reduced penalty charge;

“Penalty Charge Notice” for the purposes of Part VIII of this Order has the same meaning as in Regulation 8(1) of the 2005 Regulations;

“Penalty Charge Notice” for the purposes of Part IX and Part X, Section C of this Order means a notice issued by a parking attendant pursuant to the provisions of Section 66 of the Road Traffic Act 1991 as applied and modified by the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of South Tyneside) Order 2006;

“Public Service Vehicle”, “Stage Carriage” and “Express Carriage” have the same meanings as in The Public Passenger Vehicles Act 1981;

"Relevant Position," insofar as it relates to the display of a disabled persons badge, has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000

"Road" means any side, part or length of road or street referred to in the Schedules to this Order.

"Taxi" means a Licensed Hackney Carriage;

"Taxi Rank" means any part of a road authorised to be used as a parking place by Licensed Hackney Carriages;

PART II

SPEED RESTRICTIONS

- 1) The lengths of road specified in Schedule 30.01 shall be restricted roads for the purposes of Section 82 of the 1984 Act.
- 2) No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour on the lengths of road specified in Schedule 30.02 to this Order.
- 3) No person shall cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour on the lengths of road specified in Schedule 30.03 to this Order.
- 4) No person shall cause or permit any vehicle to proceed at a speed exceeding 50 miles per hour on the lengths of road specified in Schedule 30.04 to this Order.
- 5) Save as provided in Article 7 no person shall drive any motor vehicle at a speed exceeding 20 miles per hours on any of the lengths of road specified in Schedule 30.05 to this Order.
- 6) No person shall cause or permit any vehicle to proceed at a speed exceeding 60 miles per hour on the lengths of road specified in Schedule 30.06 to this Order.
- 7) Nothing in Part II Article 5 shall apply to a vehicle being used for fire brigade, ambulance or police purposes on emergency call.

PART III

PROHIBITION OF GOODS VEHICLES

- 1) Save as provided in Article 5 of Part III no person shall cause or permit any motor vehicle, with a maximum gross weight which exceeds 7.5 tonnes to proceed in any length of road specified in Schedule 31.01.
- 2) Save as provided in Article 5 of Part III no person shall cause or permit any motor vehicle, with a maximum gross weight which exceeds 17 tonnes to proceed in any length of road specified in **item 1 or item 2 of Schedule 31.02.**
- 3) No person shall cause or permit any motor vehicle, with a maximum gross weight which exceeds 17 tonnes to proceed in the length of road specified in **item 3 of Schedule 31.02.**
- 4) Save as provided in Articles 5 and 6 of Part III no person shall cause or permit any motor vehicle, with a maximum gross weight which exceeds 3 tonnes to proceed in any length of road specified in Schedule 31.03.

- 5) Nothing in Articles 1, 2 or 4 shall apply to any one of the following vehicles:-
- a) Any police, fire brigade or ambulance vehicle on emergency call;
 - b) Any vehicle being used for the conveyance of persons or goods or merchandise to or from any premises situated on or adjacent to the road;
 - c) Any vehicle which is being used (and which cannot conveniently be used for such purpose in any road other than a road or length of road described in the said Schedule) in connection with any of the following operations, namely –
 - (1) any building operation or demolition;
 - (2) the removal of any obstruction to traffic;
 - (3) the maintenance, improvement or reconstruction of the said road; or
 - (4) the laying, erection, alteration or maintenance in or in land adjacent to the said road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line.
- 6) Nothing in Article 2 shall apply to any vehicle, if it is used for the purpose of agriculture in connection with land adjacent to the road or for the conveyance or haulage of timber felled upon the land.

PART IV

ONE-WAY RESTRICTIONS

- 1) Save as provided in Article 2 of Part IV to this Order no person shall except upon the direction or with the permission of a police constable in uniform cause or permit any vehicle to proceed in any of the roads or lengths or road as the case may be specified in Column 2 of Schedule 32.01 of this Order in a direction other than that specified in relation to that road in Column 3 of the said Schedule.
- 2) Nothing in Article 1 of Part IV of this Order shall apply to any police, fire brigade or ambulance vehicle on emergency call.
- 3) No person shall drive or cause to be driven any vehicle in the lengths of road specified in Schedule 32.02 to this Order, otherwise than in such direction as to keep the said islands on the right-hand or off-side of the vehicle
- 4) No person shall, except when proceeding from one dual carriageway to the other, cause any vehicle to proceed in the dual carriageway of the road specified in Schedule 32.03 to this Order in such direction other than as to keep the central island or reservation on the right-hand or off-side of the vehicle, provided that with regard to King George Road, South Shields, no person shall drive or cause to be driven any vehicle so as to proceed from one dual carriageway to the other at the points specified in Column 2 of Schedule 32.01 of this Order in relation to that road in a direction other than that specified in relation to that road in Column 3 of that Schedule.

PART V

PROHIBITION OF ENTRY RESTRICTIONS

No Entry

1. Save as provided in Article 4 of Part V of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle proceeding in any of the roads described in Column 2 of Schedule 33.01 to this Order to enter the road described, in relation to that road, in Column 3 of the said Schedule.

No Entry Except for Access

2. Save as provided in Article 4 of Part V of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle proceeding in any of the roads described in Column 2 of Schedule 33.02 to this Order to enter the road described, in relation thereto, in Column 3 of the said Schedule.

No Entry for all Motor Vehicles

3. Save as provided in Article 4 of Part V of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any motor vehicle proceeding in any of the roads described in Column 2 of Schedule 33.03 to this Order to enter the road described, in relation thereto, in Column 3 of the said Schedule.
4. Nothing in Articles 1, 2 or 3 of Part V of this Order shall apply to any one of the following vehicles where so specified in relation to the said roads by reference to this paragraph of this Article in Column 4 of the Schedule:-

(1) Any police, fire brigade or ambulance vehicle on emergency call;

(2) Any vehicle which is being used (and which cannot conveniently be used for such purpose in any road other than the road or length of road described in the Schedule) in connection with any of the following operations, namely –

a) any building operation or demolition;

b) the removal of any obstruction to traffic;

c) the maintenance, improvement or reconstruction of the said road or length of road specified in Column 3 of the aforementioned Schedule, or of any road adjoining thereto to which there is no other means of access for vehicles; or

d) the laying, erection, alteration or maintenance in or near the said road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line.

(3) Any vehicle, if it cannot conveniently be used for such purpose in any road other than a road or length of road described in the said Schedule, to be used in pursuance of statutory powers or duties;

(4) Any vehicle being used for the conveyance of persons, goods or merchandise to or from any premises situated adjacent to the road or length of road; and

(5) Any vehicle in the service of the Post Office being used for the purpose of delivering or collecting postal packets as defined in Section 125 Postal Services Act 2000.

No Entry Except Buses

5. Save as provided in Article 6 of Part V of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle, other than a Public Service Vehicle operating a public transport service, school bus or works bus, proceeding in any of the roads described in Column 2 of Schedule 33.04 to this Order to enter the road described, in relation thereto, in Column 3 of the said Schedule.
6. Nothing in Article 5 of Part V of this Order shall apply to any one of the following vehicles where so specified in relation to the said roads by reference to this paragraph of this Article in Column 4 of the Schedule:-
 - (1) Any police, fire brigade or ambulance vehicle on emergency call;
 - (2) Any vehicle which is being used (and which cannot conveniently be used for such purpose in any road other than a road or length of road described in Schedule 33.04) in connection with any of the following operations, namely –
 - a) any building operation or demolition;
 - b) the removal of any obstruction to traffic;
 - c) the maintenance, improvement or reconstruction of the said road or length of road specified in Column 3 of the aforementioned Schedule, or of any road adjoining thereto to which there is no other means of access for vehicles; or
 - d) the laying, erection, alteration or maintenance in or near the said road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line.
 - (3) Any vehicle, if it cannot conveniently be used for such purpose in any road other than a road or length of road described in the said Schedule, to be used in pursuance of statutory powers or duties;

PART VI **TURNING RESTRICTIONS**

- 1) Save as provided in Article 4 of Part VI no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle proceeding in any of the roads specified in column 2 of Schedule 34.01 to this Order to make a right-hand turn into the road specified, in relation to that road, in column 3 of the said Schedule.
- 2) Save as provided in Article 4 of Part VI no person shall, except upon the direction or with the permission of a police constable in uniform cause or permit any vehicle proceeding in any of the lengths of road specified in column 2 of Schedule 34.02 to this Order to make a left-hand turn into the road specified, in relation to that road, in column 3 of the said Schedule.
- 3) Save as provided in Article 4 of Part VI no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle proceeding in any of the lengths of road or carriageways of any road, as the case may be, specified in column 2 of Schedule 34.03 to this Order in the direction and at the place specified in column 3 in relation to that road or carriageway to make a right hand turn so as to proceed in the opposite direction in that length of road or in the other carriageway of that road, as the case may be.

- 4) Nothing in Articles 1, 2 and 3 of Part VI shall apply to any police, fire brigade or ambulance vehicle on emergency call.

PART VII **PRESCRIBED TURNS**

- 1) Every person causing any vehicle to proceed in any of the roads specified in column 2 of Schedule 35.01 to this Order (in the direction indicated in column 3) shall, unless otherwise directed or permitted by a police constable in uniform, cause that vehicle on reaching its junction with the road specified in relation thereto in column 4 of the said Schedule, to make a left-hand turn into the last mentioned road.

PART VIII **PROHIBITION OF DRIVING**

Prohibition of Driving

1. Save as provided in Article 2 of Part VIII of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to proceed in the road or lengths of road specified in Schedule 36.01 to this Order.
2. Nothing in Article 1 of Part VIII of this Order shall apply to any one of the following vehicles where so specified in relation to the said roads by reference to this paragraph of this Article in Column 3 of the Schedule:-

(1) Any police, fire brigade or ambulance vehicle on emergency call;

(2) Any vehicle which is being used (and which cannot conveniently be used for such purpose in any road other than a road or length of road described in the Schedules) in connection with any of the following operations, namely –

a) any building operation or demolition;

b) the removal of any obstruction to traffic;

c) the maintenance, improvement or reconstruction of the said road or length of road specified in Column 3 of the aforementioned Schedule, or of any road adjoining thereto to which there is no other means of access for vehicles; or

d) the laying, erection, alteration or maintenance in or near the said road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line.

(3) Any vehicle being used in pursuance of statutory powers or duties;

(4) Any vehicle being used to gain access to the adjoining premises;

Prohibition of Driving except for Pedal Cycles and Public Service Vehicles

3. Save as provided in Article 8 of Part VIII of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a person duly authorised by the Council, cause or permit any motor vehicle other than a public service vehicle to proceed between 5.30 a.m. and 11.30 p.m. on any

day in the road or lengths of road specified in Schedule 36.02 to this Order, or to otherwise be in such roads or lengths of roads between those hours.

4. Save as provided in Article 8 of Part VIII of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a person duly authorised by the Council, , cause or permit any vehicle other than a pedal cycle or any public service vehicles to proceed in, or to otherwise be in, the road or lengths of road specified in Schedule 36.03 to this Order.

Prohibition of Driving except for Pedal Cycles

5. Save as provided in Article 8 of Part VIII of this Order no person shall, except upon the direction or with the permission of a police constable in uniform cause or permit any vehicle other than a pedal cycle to proceed in, or to otherwise be in, the lengths of road as set out in Schedule 36.04 to this Order.

Prohibition of Driving except for Public Service Vehicles

6. Save as provided in Article 8 no person shall, except upon the direction or with the permission of a police constable in uniform or a person duly authorised by the Council, , cause or permit any vehicle other than any public service vehicles operating a public transport service, school bus or works bus to proceed in, or to otherwise be in the road or lengths of road specified in Schedule 36.05 to this Order.

Prohibition of Driving Except for Access or Cycles

7. Save as provided in Article 8 of Part VIII of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle other than a pedal cycle to proceed in the lengths of road as set out in Schedule 36.06 to this Order.
8. Nothing in Articles 3, 4, 5, 6 and 7 of Part VIII of this Order shall apply to any one of the following vehicles where so specified in relation to the said roads by reference to this paragraph of this Article in Column 3 of the Schedule:-

(1) Any police, fire brigade or ambulance vehicle on emergency call;

(2) Any vehicle which is being used (and which cannot conveniently be used for such purpose in any road other than a road or length of road described in the Schedules) in connection with any of the following operations, namely –

a) any building operation or demolition;

b) the removal of any obstruction to traffic;

c) the maintenance, improvement or reconstruction of the said road or length of road specified in Column 3 of the aforementioned Schedule, or of any road adjoining thereto to which there is no other means of access for vehicles; or

d) the laying, erection, alteration or maintenance in or near the said road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line.

(3) Any vehicle being used in pursuance of statutory powers or duties;

(4) Any mechanical road cleansing vehicle;

(5);

(6) Any vehicle in the service of the post office being used for the purpose of delivery or collection of postal packets as defined in Section 125 Postal Services Act 2000 ;

- (7) Any heavy goods vehicle;
- (8) Any vehicle being used to gain access to or egress from the parking bays or lay-by situated adjacent to the cycle lane, provided that any vehicle for that purpose does so using the shortest possible route;
- (9) Any vehicle being used for the conveyance of goods or merchandise to or from premises situated adjacent to the cycle lane, provided that any vehicle for that purpose does so using the shortest possible route;
- (10) Any vehicle which cannot conveniently be used in any other road to wait for so long as may be necessary for the purpose of enabling goods to be loaded on or unloaded from the vehicle;
- (11) Any vehicle being used to gain access to or egress from any road having a junction with the lengths of road as set out in the Schedules to this Order, provided that any vehicle for that purpose does so using the shortest possible route;
- (12) Any pedestrian controlled vehicle;
- (13) Any vehicle which displays an exemption certificate issued by the Council;
- (14) Any vehicle being used in the course of military training operations;
- (15) Any vehicle being used for the conveyance of persons, goods or merchandise to or from premises situated on or adjacent to the road or length of road;
- (16) Any disabled person's vehicle which display in the relevant position a disabled person's badge;
- (17) Any licensed hackney carriage
- (18) Any vehicle being used in the removal of sand from the beaches adjacent to the road.

Prohibition of Driving except for Access/ Prohibition of Driving at Junctions

- 9. Save as provided in Article 10 of Part VIII no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to enter or leave the roads specified in Column 2 of Schedule 36.07 to this Order at their respective junctions with the roads specified in Column 3 of the said Schedule.
- 10. Nothing in Article 9 of Part VIII of this Order shall apply to any one of the following vehicles where so specified in relation to the said roads by reference to this paragraph of this Article in Column 4 of the Schedule:-
 - (1) Any police, fire brigade or ambulance vehicle on emergency call;
 - (2) Any vehicle which is being used (and which cannot conveniently be used for such purpose in any road other than a road or length of road described in the said Schedule) in connection with any of the following operations, namely –
 - (i) any building operation or demolition;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said road or length of road specified in Column 3 of the aforementioned items, or of any road adjoining thereto to which there is no other means of access for vehicles; or

- (iv) the laying, erection, alteration or maintenance in or near the said road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line.
- (3) Any vehicle, if it cannot conveniently be used for such purpose in any road other than a road or length of road described in the said Schedule to be used in pursuance of statutory powers or duties;
- (4) Any vehicle being used by or on behalf of a local authority for so long as may be necessary for the collection of household refuse from or the clearing of cesspools at premises adjacent to the road including or comprising that carriageway;

Prohibition of Cycles

- 11. No person shall ride or cause to be ridden any pedal cycle or tricycle on any of the footpaths or lengths of footpaths specified in Schedule 36.08 of this Order.
- 12. No person shall ride or cause to be ridden any motor cycle on any of the footpaths or lengths of footpaths specified in Schedule 36.09 of this Order.

Prohibition of Driving Except Goods Vehicles

- 13. Save as provided in Article 15 of Part VIII no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to enter the roads and lengths of road listed in Schedule 36.10 to this Order at any time.
- 14. Save as provided in Article 16 of Part VIII no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to enter the roads and lengths of road listed in Schedule 36.11 to this Order at any time.
- 15. Nothing in Article 13 of Part VIII shall apply to:-
 - (1) any vehicle which is being used for police, fire brigade or ambulance purposes;
 - (2) any vehicle which is being used (and which cannot conveniently be used for such purpose in any road other than a road or length of road described in the said Schedule) in connection with any of the following operations, namely –
 - (i) any building operation or demolition;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said road; or
 - (iv) the laying, erection, alteration or maintenance in or near the said road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line.
 - (3) any vehicle, if it cannot conveniently be used for such purpose in any road other than a road or length of road described in the said Schedule to be used in pursuance of statutory powers or duties;
 - (4) any goods vehicles being used for the purpose of loading or unloading goods to or from premises in or accessible from the road provided that such operation only takes place during the period:-
 - a) Midnight to 10.00 a.m. and 4.00 p.m. to Midnight Monday to Saturday; or
 - b) anytime on a Sunday
 - (5) any specialist security vehicle loading or unloading valuables.

16. Nothing in Article 14 of Part VIII shall apply to:-

- (1) any vehicle which is being used for police, fire brigade or ambulance purposes;
- (2) any vehicle which is being used (and which cannot conveniently be used for such purpose in any road other than a road or length of road described in the said Schedule) in connection with any of the following operations, namely –
 - (i) any building operation or demolition;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said road; or
