THE SOUTH TYNESIDE COUNCIL (FOWLER STREET SOUTH SHIELDS LOADING BAY) (WAITING AND LOADING RESTRICTION) ORDER 2008

The Council of the Borough of South Tyneside (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, and 2, 3 and 4 of The Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and by virtue of The Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of South Tyneside) Order 2006 and of all other enabling powers and after consultation with the Chief Constable of Northumbria Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

Commencement and Citation

1. This Order shall come into operation on 25 February 2008 and may be cited as "The South Tyneside Council (Fowler Street South Shields, Loading Bay)(Waiting and Loading Restriction) Order 2007".

Amendments to The South Tyneside Council (Prohibition and Restriction of Waiting)(Consolidation) (No.3) Order 2007

- 2. The South Tyneside Council (Prohibition and Restriction of Waiting) (Consolidation) (No. 3) Order 2007 is amended as follows:
- 3. In Schedule 1.01, Item number 106 relating to Fowler Street South Shields, the east side (i) is deleted and replaced with the following new row:
 - (i) from a point 68 metres south of the south kerbline of Winchester Street, for a distance of 6 metres in a southerly direction";
- 4. In Schedule 1.01, after Item number 106 relating to Fowler Street South Shields, the east side (iii) insert the following new row:
 - "(iv) from a point 101 metres south of the south kerbline of Winchester Street, in a southerly direction to the south end of the street."
- 5. In Schedule 1.01, Item number 106 relating to Fowler Street South Shields, the west side (viii) is deleted and replaced with the following new row:
 - "(viii) from a point 44 metres north of the north kerb line of Mount Terrace, northwards to a point 9 metres north of the north lerb line of Burrow Street"
- 6. In Schedule 3.01, Item number 33 relating to Fowler Street South Shields, the east side (i) is deleted and replaced with the following new row:-
 - "(i) a point 68 metres south of the south kerbline of Winchester Street, for a distance of 6 metres in a southerly direction";

- 7. In Schedule 3.01, after Item number 33 relating to Fowler Street South Shields, the east side (iii) insert the following new row:
 - "(iv) from a point 101 metres south of the south kerbline of Winchester Street, in a southerly direction to the south end of the street."
- 8. In Schedule 3.01, Item number 33 relating to Fowler Street South Shields, the west side (ii) is deleted and replaced with the following new row:
 - "(ii) from a point 57 metres south of the south kerb line of Mount Terrace, northwards for a distance of 32 metres";
- 9. In Schedule 3.01, Item number 33 relating to Fowler Street South Shields, the west side (iv) the words "50 metres" are deleted and replaced with the words "44 metres";
- 10. In Schedule 3.01, after Item number 33 relating to Fowler Street South Shields, the west side (v) insert the following new row:-
 - "(vi) from a point 10 metres south of the south kerb line of Mount Terrace, northwards to a point 4 metres north of the north kerb line of Mount Terrace";
- 11. In Schedule 6.01, Item number 8 relating to Fowler Street South Shields, the west side (ii) the words "18 metres" are replaced with the words "12 metres".
- 12. In Schedule 6.01, after Item number 8 relating to Fowler Street South Shields, the west side (ii) insert the following new row:-
 - "the east side (i) from a point 74 metres south of the south kerb line of Winchester Street, for a distance of 27 metres in a southerly direction".
