THE SOUTH TYNESIDE COUNCIL (VARIOUS CONSOLIDATION (No.3) ORDERS) (MISCELLANEOUS AMENDMENTS) ORDER 2008

The Council of the Borough of South Tyneside (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, and 2, 3 and 4 of The Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and by virtue of The Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of South Tyneside) Order 2006 and of all other enabling powers and after consultation with the Chief Constable of Northumbria Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

Commencement and Citation

1. This Order shall come into operation on 29 February 2008 and may be cited as "The South Tyneside Council (Various Consolidation(No.3) Orders) (Miscellaneous Amendments) Order 2008".

Amendments to The South Tyneside Council (Prohibition and Restriction of Waiting)(Consolidation) (No.3) Order 2007

- 2. The South Tyneside Council (Prohibition and Restriction of Waiting) (Consolidation) (No. 3) Order 2007 is amended as follows:
- 3. In Schedule 1.01, after Item number 393 relating to the Unnamed street between Nos.20 and 21 Station Road East Boldon insert the following new rows:-
 - "394 Crawley Avenue Hebburn, west side (i) from its junction with Mill Lane in a northerly direction for a distance of 21 metres;

east side (i) from its junction with Mill Lane in a northerly direction for 15 metres;

395 Mill Lane Hebburn,

- (i) from a point 16 metres west of its junction with the western kerbline of Crawley Avenue for a distance of 50 metres in an easterly direction".
- 4. In Schedule 8.02 Item number 30 relating to Valley View Primary School is revoked.
- 5. In Schedule 8.02 Item number 8 relating to Cleadon Lane, Cleadon C of E Infants School Cleadon is revoked.

Amendments to The South Tyneside Council (Movement Restrictions)(Consolidation) (No.3) Order 2007

- 6. The South Tyneside Council (Movement Restrictions)(Consolidation)(No.3) Order 2007 is amended as follows:
- 7. Part X, Section C after Article a) ii) insert the following new lines:-

"for the purposes of Article 3A of this Section of Part X to this Order all that area of a road specified in Schedule 40.03 to this Order which is comprised within and indicated by a road marking complying with either Diagram 1025.1 or Diagram 1025.3 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002"

- 8. Part X, Section C after Article 3) insert the following new lines:-
- "3A) Save as provided in Article 4 of this Section of Part X to this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant, cause or permit a vehicle, other than a stage carriage or express carriage, to wait between the hours of 5.00am. and 1.00 pm on Saturdays, Sundays and Public Holidays in the prohibited area".
- 9. Part x, Section C Article 4, after the words "Articles 2 and 3" insert the words "and 3A".
- 10. In Schedule 37.01, Item number 3 relating to Rackly Way Whitburn north side is deleted and replaced with the following
- "Rackly Way, Whitburn south side (i) In the lay-by, from a point 10 metres east of its junction with Holly Avenue in a westerly direction for a distance of 97.5 metres"
- 11. After Schedule 40.02 relating to Bus Stop Clearway 7 a.m. to 7 p.m insert Schedule 1 to this Order.
