THE SOUTH TYNESIDE COUNCIL (FORESHORE AND OFF STREET PARKING PLACES) CONSOLIDATION ORDER 2008

South Tyneside Metropolitan Borough Council (hereinafter referred to as "the Council") in exercise of the powers under Sections 1,2,3,4,5,32, 33 and 35 and Part III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act of 1984") and under the Road Traffic (Permitted Parking Area and Special Parking Area)(Metropolitan Borough of South Tyneside) Order 2006 and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following order:-

<u>PART I</u>

Commencement and Citation

 This Order shall come into operation on the 25 February 2008 and may be cited as THE SOUTH TYNESIDE COUNCIL (FORESHORE AND OFF STREET PARKING PLACES) CONSOLIDATION ORDER 2008.

Revocation of Existing Orders

2) The Orders set out in Schedule 2 to this Order are hereby revoked insofar as they relate to any of the items listed in the Schedule 1 to this order.

Construction and Interpretation

- The Interpretation Act of 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 4) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulation made or having effect as if made under the Road Traffic Regulation Act 1984 (as amended) or by or under any other enactment.
- 5) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 6) In this Order, (except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them) :-

"Coach", means a motor vehicle which is constructed or adapted for the use of conveying passengers and their effects, and carrying more than 12 passengers;

"Disabled Person" and "Disabled Person's Badge" have the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 2000 (as amended);

"Disabled Person's Vehicle" means a vehicle displaying a Disabled Person's Badge;

"Driver", in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left at the parking place;

"Foreshore parking place" means a parking place identified as such in Schedule 1 to this Order

"Goods Vehicle", means a motor vehicle not exceeding 30 cwt, which is constructed or adapted for the carriage of goods or burden of any description and is not carrying a trailer;

"Invalid Carriage", as defined by Section 136(5) of the Act of 1984;

"Motor Car", as defined by Section 136(2) of the Act of 1984;

"Motor Cycle", as defined by Section 136(4) of the Act of 1984;

"Owner", in relation to a vehicle, means the person by whom such vehicle is kept and used;

"Parking Attendant", means a person authorised by or on behalf of the Council under Section 63A of the Act of 1984 to supervise and enforce the restrictions imposed by this Order;

"Parking Place", means any area of land specified by name in column 1 of Schedule 1 to this Order provided by the Council under Section 32 of the Act of 1984 for use as a parking place;

"Parking Space", means a space in a parking place which is provided for the leaving of the vehicle;

"Passenger Vehicle", means a motor vehicle (other than a motor cycle or invalid carriage) constructed solely for the carriage of passengers and their effects and adapted to carry not more than 12 passengers exclusive of the driver and not drawing a trailer;

"Penalty Charge" and "Reduced Penalty Charge" mean a charge set by the Council under the provisions of Section 74 of the Road Traffic Act 1991 as applied and modified by the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of South Tyneside) Order 2006 in accordance with guidance given by the Secretary of State for Transport which is to be paid in the manner described in the penalty charge notice within 28 days of the date of the notice or 14 days of the date of the notice in the case of a reduced penalty charge;

"Penalty Charge Notice" means a notice issued by a parking attendant pursuant to the provisions of Section 66 of the Road Traffic Act 1991 as applied and modified by the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of South Tyneside) Order 2006;

"Permit" means an annual or periodical permit issued by the Council for use in such parking places as may be specified;

"Registered Keeper", means the person named by the Driver Vehicle Licensing Agency at Swansea as being the keeper of the vehicle;

"Season Ticket", means a permit issued under the provisions of Article 36 of this Order;

"Staff Parking Permit" for the purposes of this Order means a Permit issued by the Council to an employee of the Council;

"Ticket", means a ticket which is issued by a ticket machine in accordance with Article 32(a) of this Order and which is valid only for the time period printed thereon;

"Ticket Machine", means an apparatus or device of a type and design approved specifically or generally by the relevant e Secretary of State, being apparatus designed to indicate the time by a clock and to issue upon insertion of an appropriate coin or coins into the apparatus or device provided numbered tickets indicating the payment of a charge the period in respect of which it has been paid and the day and time at which the charge was made and the time the vehicle ought to leave the parking place;

"Town Centre parking place" means a parking place identified as such in Schedule 1 to this Order; and

"Traffic Sign", means a sign of any size, colour and type prescribed or authorised under Section 64 of the Act of 1984.

"Trailer" means any vehicle other than a motor vehicle;

"Vehicle" means motor car, motor cycle, Invalid carriage and Trailer.

Designation of Parking Places

7) Each area of land specified by name in Column 1 of Schedule 1 to this Order, may be used as a parking place for such classes of vehicles on such days and during such hours and on payment of such charges as are specified in relation to that area in the said Schedule subject to the following provisions to this Order.

Conditions of Use of Parking Places

- 8) Where in Column 3 of Schedule 1 to this Order a parking place is described as available for vehicles of a specified class, the driver of a vehicle shall not permit it to wait in that parking place unless it is of the specified class or in a position other than that specified.
- The driver of a vehicle shall not permit it to wait in a parking place for a continuous period longer than 72 hours.
- 10) The driver of a vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place, and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place.
- (11) a) Every vehicle left in a parking place specified in Column 1 of Schedule 1 to this Order shall be left in a parking space designated for that class of vehicle so that every part of the vehicle shall be wholly within the limits of the parking space, provided that where no such limits are described upon the parking place every such vehicle shall be left in accordance with the directions of a parking attendant or in such a position as will not obstruct any other vehicle from entering or leaving the parking place or a parking space within the parking place.

b) Nothing in Article 11) a) shall apply to a Goods Vehicle parking in the Pier Parade parking place between the hours of 5.30 p.m and 8.30 am.

- 12) The driver of a vehicle drawing a trailer shall not permit the vehicle or the trailer to wait in a parking place unless they have been disconnected and for the purpose of this Order the vehicle and the trailer shall be deemed to be two separate vehicles and the said driver shall be deemed to be the driver of each of the said vehicles.
- 13) No person shall use a vehicle, while it is in a parking place, in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services.

14) No person shall use any part of a parking place or cause or permit any vehicle to be left in a parking place;

- a) For sleeping or camping purposes;
- b) For cooking purposes;
- <u>c)</u> For lighting or causing to be lit any fire;

Formatted: Bullets and Numbering

- d) For the purpose of servicing or washing any vehicle or part thereof, other than is reasonably necessary to enable that vehicle to depart from the parking place.
- 15) In a parking place no person shall erect or cause or permit to be erected any tent, booth, stand, building or other structure.
- 16) No person shall, except with the permission of a parking attendant, drive any vehicle in a parking place other than for the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place.
- 17) No person shall drive any vehicle in any parking place referred to in Schedule One to this Order in a dangerous or reckless manner or otherwise without due care and attention and any person found in a vehicle so driven shall be in contravention of this Order.
- 18) The parking places shall not be used as a meeting place or point of assembly by any person outside the hours of operation of charges referred to in Schedule 1.
- 19) All persons using the parking places shall immediately comply with all reasonable requests of any parking attendant or other authorised officer appointed on behalf of the Council.
- 20) All persons using the parking places referred to in this Order shall conduct themselves in an orderly manner.
- 21) No person shall carry or otherwise possess an offensive weapon or any article so adapted in any parking place to which this Order applies.
- 22) Where, in a parking place, signs are erected or surface markings are laid for the purpose of:
 - a) Indicating the entrance to or exit from the parking place;
 - b) Indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place;
 - <u>c)</u> That certain bays are for the use of disabled persons vehicles only;

no person shall drive or cause or permit to be driven any vehicle:-

- (i) so that it enters the parking place otherwise than by an entrance, or leaves the parking place otherwise than by an exit so indicated, or
- (ii) in a direction other than that specified, as the case may be or
- (iii) park within a disabled persons parking bay unless it is a disabled persons vehicle
- 23) The driver of a motor vehicle using a parking place shall not sound any horn or other similar instrument except when about to change the position of the vehicle in or to depart from the parking place.
- 24) No person shall, in a parking place, wantonly shout or otherwise make any loud noise to the disturbance or annoyance of users of the parking place or residents or premises in the neighbourhood.
- 25) No person shall, in a parking place, use any threatening, abusive or insulting language, gesture or conduct with intent to put any person in fear or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned.
- 26) Any person not complying with Articles 8 to 25 of this Order will be in contravention of this Order.

27) Articles 8, 9, 11, 12, 13, 14 and 15 shall not apply to any person or vehicle that has the prior written permission of the Council to use a parking place in a manner prohibited by those Articles.

Removal of Vehicles from Parking Places

28)

- a) When a vehicle is left in a parking place in contravention of any of the provisions contained in Articles, 8, 9, 11, 12, and 13 of this Order, a parking attendant or any other person authorised in that behalf by the Council may remove the vehicle or arrange for it to be moved from that parking place.
- b) Where it appears to the Council that a vehicle left in a parking place has been abandoned, a person authorised in that behalf by the Council may remove the vehicle or arrange for it to be moved from that Parking place, provided that where the Council propose to move such a vehicle which in their opinion is in such a condition that it ought to be destroyed, then they shall, not less than 7 days before removing it, cause to be affixed to the vehicle a notice stating that they propose to remove it for destruction at the end of that period.
- c) Nothing in Article 28) a) of this Order shall apply to an Invalid Carriage.
- 29) Any person removing a vehicle by authority of Article 28 of this Order may do so by towing or driving the vehicle or in such other manner as he may think necessary to enable him to remove it as aforesaid.
- 30) When a parking attendant or any other person authorised by the Council removes or makes arrangements for the removal of a vehicle from a parking place by authority of Article 28 of this Order, he shall except in the case of a vehicle which in the opinion of the Council is in such condition that it ought to be destroyed make such arrangements as may be deemed reasonably necessary for the safe custody of the vehicle.

Charges in connection with the use of a Parking Place and Method of Payment

- 31) Save as provided in Article 33 of this Order, a charge shall be made for the use by a vehicle of a parking place specified in Column 1 of Schedule 1 to this Order in accordance with the scale of charges specified in Column 7 of Schedule 1 to this Order.
- 32) The driver of a vehicle using a parking place specified in Column 1 Schedule 1 to this Order shall:-
 - a) immediately after entering the parking place insert the appropriate coin or coins into a ticket machine, which shall be used as a means of collecting the charge imposed by Article 31 of this Order and which shall issue a ticket
 - b) for Town Centre parking places use the ticket or tickets referred to in Paragraph (a) of this Article only at the parking place at which it is issued, for Foreshore parking places use the ticket referred to in paragraph (a) of this Article at any of the Foreshore parking places;
 - c) leave the vehicle in the parking place only on the day of issue of the said ticket or tickets and only for the time period stated thereon commencing from the time of issue of the ticket or tickets as stated thereon provided that where more than one ticket is purchased the second and subsequent tickets shall extend the time period for which the first ticket is valid by the additional time period stated thereon;
 - attach the ticket or tickets issued to the inside of the windscreen in the case of a vehicle so fitted and in any other case in a conspicuous position on the vehicle and cause the said ticket or tickets to be exhibited in that position at all times while the vehicle is parked in the parking place;
 - e) park the vehicle wholly within the limits of a parking place not being a space reserved under the provisions of Article 42 to this Order unless the vehicle is displaying a valid season ticket or permit

issued in accordance with the provisions of Articles 36, 38, and 39 of this Order entitling the vehicle to park in that reserved space;

f) if the vehicle is issued with a valid season ticket or permit in accordance with the provisions of Articles 36, 38 and 39 of this Order display the season ticket or permit at all times while the vehicle is in the parking place on the inside of the windscreen in the case of a vehicle so fitted and in the case of a vehicle not so fitted, in a conspicuous position on the vehicle and if the conditions of issue of the season ticket or permit limit its use to a part of a parking place or to a particular parking space, park the vehicle in that part of the parking place or parking space

save that paragraphs (a), (b), (c) and (d) of this Article shall not apply in the case of a vehicle issued with a valid season ticket or permit in accordance with the provisions of Articles 36,38 and 39 of this Order.

Exemptions for Disabled Persons and Motor Cycles

- 33) The following vehicles may be left in a parking place and shall be exempt from the payment of a charge specified in Column 7 of Schedule 1 to this Order under the provisions of Article 31 of this Order provided that this exemption is limited to a period not exceeding three hours in any of the car parks listed in Schedule 1 to this Order:
 - a) An invalid carriage;
 - b) A disabled persons vehicle displaying a disabled persons badge in the relevant position on the vehicle in accordance with The Disabled Persons (Badges for Motor Vehicles) Regulations 2000 as amended;
 - c) A vehicle left by the driver thereof who is a person who on account of his severe physical disability has been given a notice in writing from the Council that he is exempt from any such charge, provided that the Notice shall be displayed on the inside of the windscreen in the case of a vehicle so fitted, and in any other case in a conspicuous position on the vehicle in respect of which it is issued;
 - d) A solo motor cycle, when parked in a parking place which is reserved for motor cycles and signed accordingly.

Installation of Ticket Machines, Placing of Traffic Signs etc.

34) The Council shall:-

- a) Install and maintain in proper working order at least one ticket machine in such a position as they think fit on or in the vicinity of each of the parking places specified in Column 1 of Schedule 1 to this Order;
- b) Cause the limits of each parking place and of each parking space to be indicated on the carriageway by placing and maintaining thereon traffic signs.;
- c) Place and maintain on or in the vicinity of each parking place traffic signs indicating that such a parking place may be used during the permitted hours for the leaving only of a vehicle specified in Column 3 of Schedule 1 of this Order; and
- d) Carry out such other work as is reasonably required for the purpose of the satisfactory operation of a parking place.

Ticket Machine Indications as Evidence

35) In any proceedings in respect of an alleged contravention of or non-compliance with this Order:-

a) Any indications as to the date, time and place on a ticket issued by a ticket machine shall be evidence that such ticket was issued and the parking time recorded according to such indications;

- b) In respect of the parking places mentioned in Column 1 of Schedule 1 to this Order the absence of a displayed ticket from a vehicle left in a parking place shall be evidence that no such ticket has been issued and that the charge specified in Column 7 of Schedule 1 to this Order has not been paid in respect thereof;
- c) It shall be assumed unless the contrary is shown that any ticket machine is of a type and design approved by the relevant Secretary of State.

Applications for and use of Season Tickets and Permits for the use of Parking Places

- 36)
 - a) The owner of a vehicle or an organisation representing the owner of a vehicle may, on application and at the discretion of the Council, purchase a Season Ticket or permit in respect of a vehicle for a charge ascertained by reference to the scale of charges in Column 7 of Schedule 1 to this Order and the Season Ticket or permit shall be valid in such parking places and parking spaces as may be specified thereon during the period for which it is issued and under the conditions stipulated thereon, subject to the provisions of Articles 37, 38 and 39 of this Order.
 - b) The Council may at any time require an applicant to produce to an officer of the Council or parking attendant such evidence in respect of an application for a Season Ticket or permit made to them as they may reasonably require to verify any particulars or information given to them or in respect of any Season Ticket or permit issued by them as they may reasonably require to verify that the Season Ticket or permit is valid.
 - c) On receipt of an application duly made under the foregoing provisions of this Article and the relevant fee, the Council, upon being satisfied that the applicant is eligible to receive a Season Ticket or permit, may issue to the applicant, either a Season Ticket or permit for leaving during the permitted hours in a parking space in a parking place specified thereon, the vehicle to which such Season Ticket or permit relates by the owner of such vehicle or by any person using such vehicle with the consent of the owner, other than a person to whom such a vehicle has been let for hire or reward.
 - d) The issue of a Season Ticket or permit shall not guarantee that any parking space will be available for use by the holder of such Season Ticket or permit.

Surrender, Withdrawal and Validity of Season Tickets and Permits

- 37)
 - a) A Season Ticket or permit holder may surrender a Season Ticket or permit to the Council at any time and shall surrender a Season Ticket or permit to the Council on the occurrence of any one of the events set out in Paragraph (c) of this Article.
 - b) The Council may by notice in writing served on the Season Ticket or permit holder by sending the same by recorded delivery to the Season Ticket or permit holder at the address shown by that person on the application for the Season Ticket or permit or at any other address believed to be that persons place of abode, withdraw a Season Ticket or permit if it appears to the Council that any of the events set out in Paragraphs (c)(i) or (c)(iii) of this Article have occurred and the Season Ticket or permit holder shall surrender the Season Ticket or permit to the Council within 48 hours of receipt of the aforementioned notice.
 - c) The events referred to in the foregoing provisions of this Article are:
 - i) The Season Ticket or permit holder ceasing to have an interest in the vehicle in respect of which the Season Ticket or permit was issued;

- ii) The withdrawal of the Season Ticket or permit by the Council under the provisions of Paragraph (b) of this Article;
- iii) The vehicle in respect of which the Season Ticket or permit was issued being adapted or used in such a manner that it is not a vehicle of the class specified in Article 36 and 39 of this Order;
- iv) The issue of a duplicate Season Ticket or permit by the Council under the provisions of Article 38 of this Order;
- v) The revision by the Council of all Season Tickets or permits relating to a particular parking place.
- d) Without prejudice to the foregoing provisions of this Article, the Season Ticket or permit shall cease to be valid at the expiration of the period specified thereon or on the occurrence of any one of the events set out in paragraphs (i) to (v) of Part (c) of this Article, whichever is the earlier.

Application for the issue of Duplicate / Replacement Season Tickets and Permits

38)

- a) If a Season Ticket or permit is mutilated or accidentally defaced or the figures or particulars thereon have become illegible or the colour of the permit has become altered by fading or otherwise, the Season Ticket or permit holder shall either surrender to the Council or apply to the Council for the issue to him of a duplicate/ replacement Season Ticket or permit and the Council, upon receipt of the Season Ticket or permit or application shall issue a duplicate / replacement Season Ticket or permit so marked and upon such issue the original Season Ticket or permit shall become invalid.
- b) If a Season Ticket or permit is lost or destroyed, the holder may apply to the Council for the issue to him of a replacement Season Ticket or permit and the Council shall issue a replacement Season Ticket or permit so marked and upon such issue the original Season Ticket or permit shall become invalid.
- c) The provisions of this Order shall apply to a duplicate / replacement Season Ticket or permit and an application for such as if it were an application, Season Ticket or permit.
- d) An application for a duplicate / replacement Season Ticket or permit under this Article may be subject to a charge equivalent to the cost of administering the duplicate / replacement Season Ticket or permit.

Form of Season Tickets and Permits

39) A Season Ticket or permit shall be issued in writing and shall include the following particulars:-

- a) The registration mark of the vehicle in respect of which the Season Ticket or permit has been issued;
- b) The period during which the Season Ticket or permit shall remain valid;
- c) The hours during which the vehicle in respect of which the Season Ticket or permit has been issued may be left in a parking place;
- d) An indication that the Season Ticket or permit has been issued by the Council;
- e) A description of the parking place, for which the Season Ticket or permit has been issued.

Restriction on Removal of Notices and Tickets

40)

- a) Where a penalty charge notice has been attached to a vehicle, no person, not being the driver of the vehicle, or a parking attendant, shall remove the notice from the vehicle unless authorised to do so by the driver.
- b) Where a ticket or tickets has or have been exhibited on a vehicle in accordance with the provisions of Article 32(d) of this Order, no person, not being the driver of the vehicle shall remove the ticket or tickets from the vehicle unless authorised to do so by the driver.

Power to Suspend Use of Parking Places

41)

- a) Subject to paragraph (b) of this Article a parking attendant may suspend the use of a parking place or any part thereof
 - i) In the case of an emergency for a period of not more than 2 hours; and
 - ii) With the approval of the Head of Streetscape for a period not exceeding 24 hours.
- b) Suspension of the use of a parking place or any part thereof wherever it is considered reasonably necessary:
 - (i) For the purpose of facilitating the movement of traffic or promoting its safety;
 - (ii) For the purpose of any building operation, demolition or excavation in or adjacent to the parking place or the maintenance improvement or reconstruction of the parking place or the laying, erection, alteration, removal or repair in or adjacent to the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line or of any traffic sign or ticket machine;
 - (iii) For the convenience of occupiers of premises adjacent to the parking place on any occasion of the removal of furniture to or from any premises adjacent to the parking place from or to a depository or other premises;
 - (iv) On any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or
 - (v) For the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals, or on other special occasions
- c) The Council, or such person or persons delegated by the Council for the purpose, may, after giving such period of public notice as is deemed reasonable in the circumstances, suspend the use of a parking place or any part thereof for any period of time wherever such suspension is considered reasonably necessary for the purposes specified in sub-paragraphs (i) to (v) above.
- d) Any person suspending the use of a parking place or any part thereof in accordance with the provisions of Paragraph (a) of this Article in the case of a parking place, the use of any part or parts of which, whether including a parking space or not, has been suspended, shall place or cause to be placed in or adjacent to that part or those parts a traffic sign or traffic signs indicating that waiting is prohibited.
- No person shall cause or permit a vehicle to be left in any part of a parking place during such period as there is in or adjacent to that part of the parking place a traffic sign placed in pursuance of Paragraph (c) of this Article, other than

- (i) a vehicle being used for fire brigade, ambulance or police purposes, or
- (ii) any other vehicle so left if that vehicle is left with the permission of a parking attendant in pursuance of Paragraph (a) of this Article.

Power to Reserve Parking Places

42)

- a) A parking attendant may reserve the use of a parking place or any part thereof, for the leaving of vehicles displaying a valid Staff Parking Permit or Season Ticket or permit issued in respect of that part of the parking place and in accordance with the provisions of Articles 36,38 and 39 of this Order.
- b) A parking attendant reserving the use of a parking place or any part thereon in accordance with the provisions of Paragraph (a) of this Article in the case of a parking place the use of any part or parts of which, whether including a parking space or not, has been reserved, shall place or cause to be placed in or adjacent to that part or those parts a traffic sign or traffic signs indicating that that part or those parts are reserved.

Charges for the Removal and Storage of Vehicles

43) Where a vehicle is removed by the Council from a parking place in pursuance of Articles 28, 29 and 30 of this Order there shall be payable to the Council pursuant to Section 102 of the Act of 1984 and the Removal and Disposal of Vehicles Regulations 1986 or any subsequent amendment thereto charges for the removal, storing and disposal of the said vehicle in accordance with the provisions of the said Regulations.

Charges for the Suspension of Parking Places and Parking Spaces

44) Where a parking space or parking place is suspended by the Council in pursuance of Articles 41of this Order there shall be payable to the Council, by the person applying for the suspension, charges equivalent to the loss of income suffered by the Council as a result of the suspension of the parking place or parking space.

Responsibility for Contraventions

- 45) When a vehicle is left in a parking place in contravention of or in non-compliance with any of the provisions contained in Articles 8, 10, 11, 12, 13, 14, 15, 16, 22,23,32,41 (e) and 52 of this Order the Registered Keeper at the time of the contravention shall be the person responsible for any contravention of or non-compliance with these said Articles.
- 46) Article 45 hereof shall not apply to the Registered Keeper of a vehicle where the Registered Keeper has proved to the satisfaction of the Council that he has entered into a bona fide written contract hiring out the vehicle at the time of any contravention recited in Article 45 as aforesaid to a third party whose name and address shall have been supplied to the Council

Closure of Parking Places

47) The parking places at Trow Quarry, Harbour Drive North and Harbour Drive South and <u>Pier Head shall be</u> closed between the hours of 10.00 p.m. and 8.00 a.m. <u>Parking Area A of Pier Head (the smaller area</u> facing the mobile homes) shall be closed between the hours of 10.00 p.m. and 8.00 a.m. and the parking places at Parking Area B of Pier Head (the larger, 'L' shaped, area) shall be closed between the hours of 1.00 a.m. and 8.00 a.m. throughout the year during which time any person found in these car parks will be in contravention of this Order.
