THE SOUTH TYNESIDE COUNCIL (PARKING PLACES) (CONSOLIDATION) ORDER 2009

The Council of the Borough of South Tyneside (hereinafter referred to as "the Council") under Sections 1,2,3,4,5,19, 32(1), 35(1), 45, 46, 49, 51, 53 and 124(1)(c), (d) and (f) and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act") and by virtue of the Traffic Management Act 2004 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of South Tyneside) Order 2006 and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following order:-

PARTI

Commencement and Citation

 This Order shall come into operation on the TYNESIDE COUNCIL (PARKING PLACES) (CONSOLIDATION) ORDER 2009.

Revocation of Existing Orders

The Orders set out in the Schedule of Revocations to this Order are hereby revoked insofar as they relate to any of the items listed in the Schedules to this Order.

Construction and Interpretation

- The Interpretation Act of 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 4) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulation made or having effect as if made under the Road Traffic Regulation Act 1984 (as amended) or by or under any other enactment.
- 5) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 6) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-

"Civil Enforcement Officer" means a person authorised by or on behalf of South Tyneside Council under Section 76 of the Traffic Management Act 2004 to supervise and enforce the road traffic contraventions for which South Tyneside Council is the enforcement authority;

"Carriageway" means a way constituting or comprised in a highway being a way (other than a cycle track) over which the public have a right of way for the passage of vehicles;

"Disabled Person's Badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 2000 (as amended);

"Disabled Person's Vehicle" means a vehicle displaying a Disabled Person's Badge:

"Driver" in relation to a vehicle waiting in a parking place means the person driving the vehicle at the time it was left in the parking place;

"Dual Purpose Vehicle" has the same meaning as in Schedule 6 of the 1984 Act;

"Enforcement Authority" means the Council of the Borough of South Tyneside;

"Goods" includes postal packets of any description and "delivering" or collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection:

"Goods Vehicle" means a motor vehicle not exceeding 30cwt unladen weight which is constructed or adapted for use for the carriage of goods of any description and is not drawing a trailer;

"Higher Level Contraventions" are as defined in the Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 or any amendment or re-enactment thereof;

"Layby" means any area of carriageway intended for the waiting of vehicles and bounded partly by a traffic sign of the type shown in Diagram 1010 in Schedule 2 to the Traffic Signs Regulations and General Directions 1994, and partly by the outer edge of that carriageway on the same side of the road as that on which the sign is placed;

"Legally qualified Medical Practitioner" for the purpose of Schedule 24.04 means any legally qualified medical practitioner whose practice is situated at No. 2 Broughton Road, South Shields;

"Lower Level Contraventions" means all parking contraventions which are not higher level contraventions;

"Medical Practitioner's Permit" means a permit issued under the provisions of Articles 17 to 21 of Section B of this Order;

"Medical Practitioner's Permit holder" means a person to whom a permit has been issued under the provisions of Articles 17 to 21 of Section B of this Order;

"Main carriageway" means any carriageway used primarily by through traffic, including any carriageway of a slip road, but excluding any lay-by;

"Motor Car and Invalid Carriage have the same meaning respectively as in Section 136 of the Act of 1984;

"Motor Cycle" means a two wheeled vehicle propelled by mechanical power and not having a sidecar or trailer attached thereto;

"Parking bay" means a space in a parking place which is provided for the leaving of a vehicle;

"Parking Contravention" has the same meaning assigned to it by Section 73 and Part 1 of Schedule 7 to the Traffic Management Act 2004;

"Parking Charge" means an amount set by South Tyneside Council payable at a ticket machine or ticket issuing machine in respect of a vehicle left in a parking place;

"Parking disc" means a disc, issued by a local authority, 125 millimetres square and capable of showing the quarter hour period during which a period of waiting begins;

"Parking Place" means any part of road described in the Schedules authorised by this Order to be used as a parking place.

"Parking Permit" means a permit issued by the Council under the Provisions of Section B, Articles 11 to 16 of this Order and for a charge to be determined by the Council and used in a manner directed by the Council;

"Passenger vehicle" means a motor vehicle (other than a motor cycle or an invalid carriage) constructed solely for the carriage of passengers and their effects and adapted to carry not more than twelve passengers exclusive of the driver, and not drawing a trailer;

"Penalty Charge" and "Reduced Penalty Charge" means a charge set by South Tyneside Council in accordance with the provisions of Section 77 and Schedule 9 of the Traffic Management Act 2004 and Regulations made thereunder and in accordance with any guidance given by the Secretary of State;

"Penalty Charge Notice" means a notice issued by a civil enforcement officer pursuant to the provisions of Section 78 of the Traffic Management Act 2004 and Regulations made thereunder;

"Permit holder" means a person to whom a permit has been issued under the provisions of Section B, Articles 11 to 16 of this Order:

"Public Service Vehicle" has the same meaning as in the Public Passenger Vehicles Act 1981;

"Registered Keeper" means the person named by the Driver Vehicle Licensing Agency at Swansea as being the keeper of the vehicle;

"Relevant Position," insofar as it relates to the display of a disabled persons badge or parking disc, has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 (as amended);

"Road" means any side, part or length of road or street referred to in the Schedules of this Order.

"Licensed Hackney Carriage" means a vehicle licensed by a Local Authority to operate as a taxi as defined in Regulation 4 of The Traffic Signs Regulations and General Directions 2002;

"Taxi Rank" means any part of a road authorised by this Order to be used as a parking place by Licensed Hackney Carriages;

"Ticket" means a ticket issued by a ticket issuing machine relating to any parking place;

"Ticket issuing machine" means an apparatus designed to indicate the time externally and to issue numbered tickets indicating the payment of a charge, the expiry of the period in respect of which the charge was paid, and incorporating the identification mark of the machine from which the ticket has been issued:

"Ticket issuing machine relating to a parking place" means a ticket issuing machine situated within reasonable walking distance of the parking place;

"Traffic Sign" means a sign of any size, colour and type prescribed or authorised under or having effect as though prescribed or authorised under Section 64 of the Act of 1984;

"Verge" means any part of a road which is not a carriageway.

Level of penalty charges

- 7) Where a penalty charge is payable under the provisions of Part VI of the Traffic Management Act 2004, the penalty charge for higher level contraventions will be set at Band 2 as defined in the provisions of the Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 or any amendment or re-enactment thereof.
- 8) All other contraventions of this Order and payable under the provisions of Part VI of the Traffic Management Act 2004 not so defined as higher level contraventions in accordance with the Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 or any amendment or re-enactment thereof, will be set at the lower level penalty charge as defined in those Regulations.

PART II

SECTION A

PARKING PLACES

Limited Waiting in Parking Places

1)

1

- a) Each of the parts of road specified in any Schedule listed in Column 1 of Tables 1 and 2 of this Order is authorised to be used, subject to the following provisions of this Article and to the provisions of Section B of this Order as a parking place during the days and hours relating to that Schedule as specified in Column 2 of those tables for the parking of such classes of vehicle as are specified in Column 3 of that Schedule, provided that no vehicle shall:-
 - i) cause or permit a vehicle to wait in that parking place for a longer period of time than the maximum period of waiting specified in Column 3 of Tables 1 or 2 relating to that Schedule in those tables; or
 - ii) cause or permit any vehicle that has left any part of road specified in any of the said Schedules during the times relating to that Schedule, to wait again upon that road after the termination of that period of waiting within the period of time stated in Column 4 of Tables 1 or 2 relating to that Schedule in those tables.

Limited Waiting Except Permit Holders

- b) The provisos set out in Article 1(a) parts (i) and (ii) above shall not apply in respect of a vehicle parked in a parking place specified in any Schedule listed in Table 2 of this Order which displays a valid parking permit issued under the provisions of Articles 11 to 16 of Section B of this Order.
- c) Nothing in parts (a) and (b) of this Article shall render it unlawful for a vehicle to wait if it is doing so in the circumstances provided for in the exemptions listed in Section C of this Order, provided that the vehicle is parked in accordance with the provisions of Section B of this Order.
- d) Nothing in parts (a) and (b) of this Article shall apply to:
 - i) an invalid carriage;
 - ii) a disabled person's vehicle displaying a disabled person's badge in the relevant position on the vehicle;
 - iii) a vehicle left by the driver thereof who is a person who on account of his severe physical disability has been given notice in writing from the Council or its Agents and such notice is displayed on the inside of the windscreen in the case of a vehicle so fitted and in any other case in a conspicuous position on the vehicle in respect of which it is issued.

Pay and Display

- 2)
- a) Save as provided in paragraphs (c) and (d) of this Article, each of the parts of road specified in Schedule 22.01 of this Order is authorised to be used, subject to the following provisions of this Article and of Section B of this Order as a parking place between the hours of 9.00 a.m. and 6.00 p.m. Mondays to Saturdays inclusive for the parking of such classes of vehicle as are specified in column 3 of that Schedule and on payment of such charge as is specified in relation to each length of road in column 6 of the said Schedule.
- b) Save as provided in paragraphs (c) and (d) of this Article, each of the parts of road specified in Schedule 22.02 of this Order is authorised to be used, subject to the following provisions of this Article and of Section B of this Order as a parking place between the hours of 9.30 a.m. and 8.30 p.m. on any day between 1 January and 31 December for the parking of such classes of vehicle as are specified in

column 3 of that Schedule and on payment of such charge as is specified in relation to each length of road in column 6 of the said Schedule.

b)i) Save as provided in paragraphs (c) and (d) of this Article, each of the parts of the road specified in Schedule 22.03 of this Order is authorised to be used, subject to the following provisions of this Article and of Section B of this Order as a parking place between the hours of 9.00 a.m. and 6.00 p.m. Mondays to Sundays inclusive for the parking of such classes of vehicles as are specified in Column 3 of that Schedule and on payment of such charge as is specified in relation to each length of road in Column 6 of the said Schedule.

c) A vehicle parked in accordance with the provisions of Section C of this Order shall be exempt from the charge referred to in paragraphs a), b), b i) and c) of this Article and specified in Column 6 of the Schedules. **Comment:** Inserted by STC (On Street Parking Pay and Display)(Days of Operation) Order 2008

- d) Nothing in paragraphs (a), (b), (bi)) or (c) of this Article shall apply to:
 - i) an invalid carriage;
 - a disabled person's vehicle displaying a disabled person's badge in the relevant position on the vehicle;

iii) a vehicle left by the driver thereof who is a person who on account of his severe physical disability has been given notice in writing from the Council or its Agents and such notice is displayed on the inside of the windscreen in the case of a vehicle so fitted and in any other case in a conspicuous position on the vehicle in respect of which it is issued.

e) The maximum number of parking bays within a parking place, where applicable, shall be specified in column 4 of the Schedules.

Imposition of Charges

- f) Save as provided in the exemptions listed in Section C of this Order there shall be a charge for the parking of a vehicle in a parking place described in Schedules 22.01 and 22.02 and Schedule 22.03 as indicated in column 6 of the Schedule relating to that parking place.
- g) The driver of a vehicle using a parking place specified in Schedules 22.01 or 22.02 or Schedule 22.03 which is subject to the payment of a Charge as specified in Column 6 of that Schedule of this Order shall:-
 - i) immediately after entering the parking place insert the appropriate coin or coins into a ticket machine, which shall be used as a means of collecting the charge imposed by this Order and which shall issue a numbered ticket or tickets indicating the period for which the charge has been paid and the day of issue of the said ticket or tickets;
 - ii) leave the vehicle in the parking place only on the day of issue of the said ticket or tickets and only for the time period stated thereon commencing from the time of issue of the ticket or tickets as stated thereon provided that where more than one ticket is purchased the second and subsequent tickets shall extend the time period for which the first ticket is valid by the additional time period stated thereon;
 - iii) attach the ticket or tickets issued to the inside of the windscreen in the case of a vehicle so fitted and in any other case in a conspicuous position on the vehicle and cause the said ticket or tickets to be exhibited in that position at all times while the vehicle is parked in the parking place.
- h) If a vehicle is left in a parking place with no ticket displayed or for longer than the period for which payment was made by the charge, it shall be a contravention of this traffic regulation order.

i) Where a ticket has been exhibited on a vehicle in accordance with paragraph iii) of Article 2(g) no person, not being the driver of the vehicle, shall remove the ticket from the vehicle unless authorised to do so by the driver.

Ticket Machine Indications as Evidence

- j) In any proceedings in respect of an alleged contravention of or non-compliance with this Order:-
 - any indications as to the date, time and place on a ticket issued by a ticket machine shall be evidence that such ticket was issued and the parking time recorded according to such indications;
 - ii) in respect of the parking places mentioned in Schedules 22.01 or 22.02 or 22.03 of this Order the absence of a ticket from a vehicle left in a parking place shall be evidence that no such ticket has been issued and that the charge specified in Column 6 of that Schedule has not been paid in respect thereof;
 - iii) it shall be assumed unless the contrary is shown that any ticket machine is of a type and design approved by the Secretary of State for the Environment.

Disabled Parking Places

- 3)
- a) Each area of highway described in any Schedule listed in Table 3 of this Order is authorised to be used, subject to the provisions of this Article and of Section B of this Order, as a parking place, only for the use of an invalid carriage or a disabled person's vehicle which displays in the relevant position a disabled person's badge and parking disc during the days and hours relating to that Schedule as specified in Column 2 of that table, provided that no person shall:-
 - i) cause or permit a vehicle to wait in that parking place for a longer period of time than the maximum period of waiting specified in Column 3 of Table 3 relating to that Schedule in the table;
 - ii) cause or permit any vehicle that has left any part of road specified in any of the said Schedules during the times relating to that Schedule, to wait again upon that road after the termination of that period of waiting within the period of time stated in Column 4 of Table 3 relating to that Schedule in the table.
- b) The maximum number of parking bays within a parking place, where applicable, described in the Schedules listed in Table 3 shall be specified in column 4 of that Schedule.

Free Parking Places

- 4)
- a) Each of the parts of road specified in Schedule 24.01 is authorised to be used, subject to the provisions of this Article and of Section B of this Order as a parking place for the parking of such classes of vehicle as are motor cars, cycles or invalid carriages at any time on any day without limit on time
- b) Nothing in part (a) of this Article shall prohibit any person from causing or permitting any vehicle to wait in the parking place if it is doing so in the circumstances provided for in the exemptions listed in Section C of this Order, provided that the vehicle is parked in accordance with the provisions of Section B of this Order.

Coach Parking Places

5) Each of the parts of road specified in Schedule 24.02 is authorised to be used, subject to the provisions of this Article and of Section B of this Order as a parking place for the parking of such classes of vehicle as are public service vehicles at any time on any day for a period of 10 minutes.

Doctor's Parking Places

- 6
- a) The areas of highway comprising the lengths of carriageway of road specified in the Schedule 24.03 of this Order and bounded on one side of those lengths by the edge of the carriageway and having a width throughout of approximately 2.00 metres are hereby authorised to be used, subject to the provisions of this Part of this Order as parking places for the leaving of such vehicles as display, in the manner specified in paragraph (d) of this Article, a valid medical practitioner's permit issued in respect of those vehicles and relating to those parking places between the hours of 8.00 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive.
- b) The areas of highway comprising the lengths of carriageway of road specified in the Schedule 24.04 of this Order and bounded on one side of those lengths by the edge of the carriageway and having a width throughout of approximately 2.00 metres are hereby authorised to be used, subject to the provisions of this Part of this Order as parking places for the leaving of such vehicles as display, in the manner specified in paragraph (d) of this Article, a valid medical practitioner's permit issued in respect of those vehicles and relating to those parking places between the hours of 8.00 a.m. to 11.00 a.m. and 4.00 p.m. to 7.00 p.m. on Mondays to Saturdays inclusive.
- c) The number of parking bays in the parking places specified in the Schedules 23.03 and 23.04 of this Order shall be the number specified in relation thereto in Column 4 of those Schedules.
- d) At all times during which a vehicle is left in a parking place referred to in the said Schedule the driver thereof shall cause to be displayed on the front or nearside of the vehicle a valid medical practitioner's permit issued in respect of that vehicle and relating to that parking place so that all the particulars

referred to in Article 20 of Section B of this Order are readily visible from the front or nearside of the vehicle.

- e) Every vehicle left in a parking place specified in Schedules 24.03 and 24.04 in accordance with the foregoing provisions of this Article shall so stand:
 - i) that the left or nearside of the vehicle is adjacent to the left hand edge of the carriageway;
 - ii) that the distance between the edge of the carriageway and the nearest wheel of the vehicle is not more than twelve inches; and
 - iii) that every part of the vehicle is within the limits of a parking space.
- f) where a vehicle is standing in a parking place in contravention of the provisions of paragraph (e) of this Article, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.
- g) Where a civil enforcement officer is of the opinion that the provisions contained in Articles 22 to 24 of Section B of this Order have been contravened he may remove or cause to be removed the vehicle from the parking place, and, where it is so removed, shall provided for the safe custody of the vehicle.
- h) A police constable in uniform or a civil enforcement officer may, in case of emergency, move or cause to be moved any vehicle left in a parking place to any place he thinks fit.

Residents' Permit Parking Places

- 7)
- a) Each of the parts of a road specified in Schedule 24.05 of this Order is authorised to be used, subject to the provisions of this Article and of Section B of this Order, as a parking place for the parking of such classes of vehicles as specified in Column 3 of that Schedule of this Order as display in the manner specified in Article 15 of Section B of this Order a valid parking permit issued by the Council under Article 11 or 13 of Section B of this Order in respect of that vehicle.
- b) Each of the parts of a road specified in Schedule 24.06 of this Order is authorised to be used, during the periods specified in Column 5 of that Schedule of this Order, and subject to the provisions of this Article and of Section B of this Order, as a parking place for the parking of such classes of vehicles as specified in Column 3 of that Schedule of this Order as display, in the manner specified in Article 15 of Section B of this Order, a valid parking permit issued by the Council under Article 11 or 13 of Section B of this Order in respect of that vehicle.
- c) Nothing in parts (a) or (b) of this Article shall render it unlawful for a vehicle to wait if it is doing so in the circumstances provided for in the exemptions listed in Section C of this Order, provided that the vehicle is parked in accordance with the provisions of Section B of this Order.
- d) Nothing in parts (a) or (b) of this Article shall apply to:
 - i) an invalid carriage;
 - ii) a vehicle left by the driver thereof who is a person who on account of his severe physical disability has been given notice in writing from the Council or its Agents and such notice is displayed on the inside of the windscreen in the case of a vehicle so fitted and in any other case in a conspicuous position on the vehicle in respect of which it is issued.

PART II

SECTION B

USE OF PARKING PLACES

- The limits of each parking place and the limits of any parking bay shall be indicated on the carriageway by the Council placing and maintaining thereon the appropriate traffic signs which will indicate the permitted hours and the specified users of the parking places.
- 2) Nothing in Articles 1 to 7 of Section A shall restrict the power of the Council, by order, on the occasion of any public procession, rejoicing or illumination, or where the street is thronged or liable to be obstructed, to close or partially close or suspend any parking place.
- 3) Nothing in Articles 1 to 7 of Section A shall render it unlawful to cause any vehicle to wait in any road specified in any Schedule to enable the vehicle to be used for fire brigade, ambulance or police purposes.
- 4) Save as provided in Articles 3 and 8 of this Section and in Section C of this Order, where a parking place in any Schedule of this Order is described in column 3 as available for vehicles of a specified class, the driver of a vehicle other than that specified class shall not permit it to wait in that parking place unless authorised to do so by a civil enforcement officer and no vehicle shall use a parking place so as to unreasonably prevent access to any premises adjoining the road by other persons, or so as to be a nuisance.

Provided always that a police constable in uniform or a civil enforcement officer may at any time require the driver of the vehicle to move it if reasonably necessary for the purpose of preventing obstruction.

- 5) The driver of any vehicle left in a parking place shall cause such vehicle to be left;
 - a) in a parking bay, so that every part of the vehicle shall be within the limits of the marked parking bay;
 or
 - b) where no parking bays are provided in a parking place, so that every part of the vehicle is wholly within the limits of the marked parking place as indicated by traffic sign thereon.
- 6) The driver of a motor vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place, and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place.
- 7) No person shall use a vehicle, while it is in a parking place, in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services or any other person's skill or services.

Removal of vehicles from parking places

8)

- a) Subject to the proviso hereto, when a vehicle is left in a parking place in contravention of any of the provisions contained in Articles 4 or 5 of this Section a civil enforcement officer may remove or cause the vehicle to be removed from the parking place.
 - Provided that when a vehicle is waiting in the parking place in contravention of the provisions of Article 5 of this Section, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with that provision.
- b) A police constable in uniform or civil enforcement officer may, in case of emergency, move or cause to be moved any vehicle left in a parking place to any place he thinks fit.
- 9) Any person removing a vehicle or altering its position by virtue of Article 8 of this Section, may do so by towing or driving the vehicle or in such manner as he may think necessary to enable him to remove it or alter its position as the case may be.
- 10) When a civil enforcement officer removes or makes arrangements for the removal of a vehicle from the parking place by virtue of Article 8 of this Section, he shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle and its contents.

PERMITS

Residents Parking Permits

11)

- a) Any occupier of premises situated in the roads or parts of roads specified in column 1 of Schedule A of this Order, which do not have alternative parking facilities, may apply to the council for the issue of a maximum of 2 parking permits for the parking of such classes of vehicle as are specified in column 3 of that Schedule in the parking places located in the roads specified opposite thereto in column 2 of the said Schedule and any such application shall include the particulars and information required by such form.
- b) Notwithstanding any other provision contained in this Order, the Trustees of the Westoe Towers Seamen's Home and Club, the Trustees of Talbot Memorial House and the St. John's Ambulance Corps may make application for permits in accordance with Paragraph 11)a) above in respect of parking places located on Westoe Village.
- c) The Council may at any time require an applicant for a permit to produce to an officer of the Council or a civil enforcement officer such evidence in respect of the application as they may reasonably require to verify any particulars or information given to them or in respect of any permit issued by them as they may reasonably require to verify that the permit is valid.
- d) On receipt of an application duly made under the foregoing provisions of this Section and the relevant fee, the Council, upon being satisfied that the applicant is eligible to receive a permit, may at its discretion issue to that applicant a permit for the parking, in a parking place described in any Schedule listed in Table 2 of Section A of this Order or in a parking place described in Schedule 24.05 or Schedule 24.06, of the vehicle to which such permit relates by the owner of such vehicle or by a person using such vehicle with the consent of the owner (other than a person to whom such vehicle has been let for hire or reward)
- e) The issue of a permit shall not guarantee that any parking bay will be available for use by the holder of such permit.

Surrender, withdrawal and validity of Permits

12

- a) A permit holder may surrender a parking permit to the Council at any time and shall do so on the occurrence of any one of the events set out in paragraph c) of this Article.
- b) The Council may, by Notice in writing served on the permit holder by sending the same by recorded delivery service to the permit holder at the address shown by that person on the application for the permit or at any other address believed to be that person's residence, withdraw a permit if it appears to the Council that any of the events set out in paragraphs c)(i) and c)(vi) of this Article have occurred, and the permit holder shall surrender the permit to the Council within 48 hours of the receipt of the said Notice.
- c) The events referred to in the foregoing provisions of this Article are:
 - i) The permit holder ceasing to have an interest in the vehicle in respect of which the permit was issued:
 - ii) The withdrawal of the permit by the Council under the provisions of paragraph c) of Article 11;
 - iii) The vehicle in respect of which the permit was issued being adapted or used in such a manner that it is not a vehicle of a class specified in column 3 of Schedule A of this Order;
 - iv) The issue of a duplicate permit by the Council under the provisions of Article 13 of this Section;
 - The revision by the Council of all permits relating to a particular parking place; or
 - vi) The permit having been used in contravention of the provisions of this order.
- d) Without prejudice to the foregoing provisions of this Article, the permit shall cease to be valid at the expiration of the period specified thereon or on the occurrence of any one of the events set out in Paragraph c) of this Article, whichever is the earlier.
- e) Notwithstanding any other provision of this Order any permit issued to the Trustees of the Westoe Towers Seamen's Home and Club, the Trustees of Talbot Memorial House and the St. John's Ambulance Corps in accordance with Article 11(b) of this Section shall not contain any reference to a particular vehicle and may be used by any person with the consent of the said Trustees for the time being in respect of any vehicle having business at their respective premises provided that all other terms and conditions relating the the issue and control of permits as contained in this Section shall apply thereto.

Application for and issue of duplicate permits

13)

- a) If a permit has become mutilated or defaced or the figures or particulars on it have become illegible or the colour of the permit has become altered by fading or otherwise, the permit holder shall either surrender it to the Council or apply to the Council for the issue to him of a duplicate permit and the Council, upon receipt of the permit, shall issue a duplicate permit so marked and upon such issue the original permit shall become invalid.
- b) If a permit is lost or destroyed, the permit holder may apply to the Council for the issue to him of a duplicate permit and the Council shall issue a duplicate permit so marked and upon such issue the original permit shall become invalid.
- c) The provisions of this Order shall apply to a duplicate permit and an application for such permit as if it were a permit or, as the case may be, an application for a permit.

Form of Permits

- 14) A valid permit shall be in writing and shall include the following particulars:
 - a) The registration number(s) of the vehicle(s) in respect of which the permit has been issued;
 - <u>b</u>) The period during which, subject to the provisions of 12(c) of this Section, the permit shall remain valid;
 - c) A description of the parking place, for which the permit has been issued; and
 - d) An authentication that the permit has been issued by the Council.

Display of Permits

- 15) The driver of a vehicle using a parking place specified in any Schedule listed in Table 2 of Section A of this Order or in Schedule 24.05 or Schedule 24.06 of this Order shall, if the vehicle is issued with a valid permit in accordance with the provisions of Articles 11 to 14 of this Section, display the permit at all times while the vehicle is in the parking place on the inside of the windscreen in the case of a vehicle so fitted and in the case of a vehicle not so fitted, in a conspicuous position on the vehicle so that all the particulars referred to in Article 14 are readily visible from outside the vehicle.
- 16) When a permit has been displayed on a vehicle in accordance with the provisions of Article 15 of this Section, no person, not being the driver of the vehicle, shall remove the permit from the vehicle unless authorised to do so by the driver of the vehicle.

Medical Practitioner's Permits

Application for and Issue of Medical Practitioner's Permits for the Use of a Parking Place

17

- a) Any legally qualified medical practitioner may apply to the Council for the issue of a Medical Practitioner's Permit in respect of each vehicle which shall be specified in the application any such application shall be made on a form issued by and obtainable from the Council and shall include the particular information and authentication required by such form to be supplied.
- b) The Council may at any time require an applicant for a Medical Practitioner's Permit to produce to an officer of the Council such evidence in respect of an application as they may reasonably require to verify any particulars or information given to them.
- c) Upon receipt of an application duly made under the foregoing provisions of this Article, the Council may issue to the applicant a Medical Practitioner's Permit for the leaving in the parking place specified thereon of such vehicles specified in the application as they are satisfied are used by legally qualified medical practitioners.
- d) Without prejudice to the provisions of Article 19 of this Section, where the Council have issued a Medical Practitioner's Permit or permits in relation to the parking place, the Council shall not issue any further Medical Practitioner's Permits in relation to that parking place which would be valid during any period during which any other Medical Practitioner's Permit is or would be valid.

18)

- a) A Medical Practitioner's Permit holder may surrender a Medical Practitioner's Permit to the Council at any time and shall do so on the occurrence of any one of the events set out in paragraph c) of this Article
- b) The Council may, by Notice in writing served on the Medical Practitioner's Permit holder by sending the same by the recorded delivery service to the Medical Practitioner's Permit holder at the address shown by that person on the application for the Medical Practitioner's Permit or at any other address

believed to be that person's residence, withdraw a Medical Practitioner's Permit if it appears to the Council that any of the events set out in Paragraphs c)(i) or c(iii) of this Article has occurred, and the Medical Practitioner's Permit holder shall surrender the Medical Practitioner's Permit to the Council within 48 hours of the receipt of the said Notice.

- c) the events referred to in the foregoing provisions of this Article are:
 - i) the vehicle or any vehicle in respect of which the Medical Practitioner's Permit was issued ceasing to be used by a legally qualified medical practitioner;
 - ii) The withdrawal of such permit by the Council under paragraph b) of this Article;
 - iii) The revocation of the parking place in respect of which the Medical Practitioner's Permit was issued:
 - iv) The issue of a duplicate Medical Practitioner's Permit by the Council under the provisions of Article 20 of this Section;
 - The Medical Practitioner's Permit ceasing to be valid pursuant to the provisions of paragraph d) of this Article;
- d) Without prejudice to the foregoing provisions of this Article a Medical Practitioner's Permit shall cease to be valid at the expiration of the period specified thereon (which period shall not exceed a period of 12 months) from the beginning of the month during which it first became valid or on the occurrence of any one of the events set out in paragraphs (c)(i) to (c)(iv) of this Article, whichever is the earlier.

Application for and issue of duplicate Medical Practitioner's Permits

19)

- a) If a Medical Practitioner's Permit has become mutilated or accidentally defaced or the figures or particulars on it have become illegible or the colour of the Medical Practitioner's Permit has become altered by fading or otherwise, the Medical Practitioner's Permit holder shall either surrender it to the Council or apply to the Council for the issue to him of a duplicate Medical Practitioner's Permit and the Council, upon receipt of the Medical Practitioner's Permit, shall issue a duplicate Medical Practitioner's Permit so marked and upon such issue the Medical Practitioner's Permit shall become invalid.
- b) If a Medical Practitioner's Permit is lost or destroyed, the Medical Practitioner's Permit holder may apply to the Council for the issue to him of a duplicate Medical Practitioner's Permit and the Council, upon being satisfied as to such loss or destruction, shall issue a duplicate Medical Practitioner's Permit so marked and upon such issue the Medical Practitioner's Permit shall become invalid.
- c) The provisions of this Order shall apply to a duplicate Medical Practitioner's Permit and an application for such Medical Practitioner's Permit as if it were a Medical Practitioner's Permit or, as the case may be, an application for a Medical Practitioner's Permit.

Form of Medical Practitioner's Permits

- 20) A medical practitioner's permit shall be in writing and shall include the following particulars:
 - a) The address of the parking place to which the Medical Practitioner's Permit relates;
 - b) The period during which, subject to the provisions of Article 18(d) of this Section, the Medical Practitioner's Permit shall remain valid:
 - c) An indication that the Medical Practitioner's Permit has been issued by the Council.

21) Where a Medical Practitioner's Permit has been displayed on a vehicle in accordance with the provisions of Article 6(d) of Section A of this order, no person, not being the driver of the vehicle, shall remove the Medical Practitioner's Permit from the vehicle unless authorised to do so by the driver of the vehicle.

POWER TO SUSPEND THE USE OF PARKING PLACES

- 22) A civil enforcement officer or other person duly authorised by the Council may suspend the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary:
 - a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - b) for the purpose of any building operation, demolition or excavation in or adjacent to the parking place
 or the maintenance, improvement or reconstruction of the highway or the cleansing of gullies in or
 adjacent to the parking place, the laying, erection, alteration or repair of any sewer or of any main,
 pipe or apparatus for the supply or gas, water or electricity or of any telegraphic line or the placing,
 maintenance or removal of any traffic sign;
 - for the convenience of occupiers of premises adjacent to the parking place on any occasion of the removal of furniture to or from one office or dwellinghouse to another or the removal of furniture from such premises to a depository or to such premises from a depository;
 - d) on any occasion on which it is likely by reason of some special attraction that any street will be through or obstructed; or
 - for the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals, or on other special occasions.
- 23) Any person suspending the use of a parking place or any part thereof in accordance with the provisions of Article 22 of this Section, in the case of a parking place the use of any part or parts of which, whether including a parking space or not, has been suspended, shall place or cause to be placed in or adjacent to that part or those parts, a traffic sign or traffic signs indicating that waiting by vehicles is prohibited.
- 24) No person shall cause or permit a vehicle to be left in any parking place or part thereof during such period as there is in or adjacent to that parking place or part thereof a traffic sign placed in pursuance of Article 24 of this Section, other than:-
 - a) a vehicle being used for fire brigade, ambulance or police purposes, or a vehicle (other than a
 passenger vehicle) in the service of a local authority, in either case being used in pursuance of
 statutory powers or duties;
 - b) a vehicle waiting only for so long as is necessary to enable a person to board or alight from the vehicle;
 - any other vehicle so left if that vehicle is left with the permission of a civil enforcement officer or other authorised person in pursuance of Article 22 of this Section
- 25) In the case of a vehicle in respect of which a penalty charge is payable, a penalty charge notice may then be issued by a civil enforcement officer.

PART II

SECTION C

EXEMPTIONS

- 1. Without Prejudice to the foregoing provisions of this Order with respect to vehicles which are left in a parking place in accordance with those provisions, any vehicle may wait anywhere on the carriageway in a parking place, other than a parking place or part of a parking place the use of which has been suspended:
 - a) for as long as may be necessary to enable a person to board or alight from the vehicle;
 - to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, other than the road(s) specified in the said Articles to be used in connection with any of the following operations, namely –
 - (i) any building operation or demolition;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the parking place so referred to;
 - (iv) the laying, erection, alteration or maintenance in or near the said parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act, 1878.
 - for the purpose of posting or removing advertising material on or from premises adjoining any of the said roads;
 - d) to enable the vehicle to be used for police, fire brigade or ambulance purposes;
 - to enable the vehicle to be used in the service of a local authority or a water authority in pursuance of statutory powers or duties;
 - to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to any of the said roads;
 - g) to enable the vehicle if it is in the service of the Post Office to be used for the purpose of delivering or collecting postal packets as defined in Section 125 Postal Services Act 2000;
 - h) to enable the vehicle, being a licensed hackney carriage, to enable the vehicle to wait upon an authorised taxi rank.
 - to enable goods to be loaded on or unloaded from the vehicle at any premises fronting the parking place;
 - if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident;
 - k) to enable the vehicle to wait on any of the lengths of road or carriageways of a road aforesaid while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged is opened or closed, if it is not reasonably practicable for the vehicle to wait otherwise than on that road or carriageway while such gate or barrier is being opened or closed.

- Nothing in Part II of this Order shall render it unlawful to cause or permit any vehicle to wait on any of the roads referred to in those Articles if a vehicle is waiting in any case where the person in control of the vehicle:
 - a) is required by law to stop;
 - b) is obliged to stop in order to avoid an accident; or
 - c) is prevented from proceeding by circumstances outside his/her control.

Formatted: Bullets and Numbering

- Nothing in Part II of this Order shall render it unlawful to cause or permit any vehicle which displays in the relevant position a disabled person's badge to wait in any parking place.
- 4. Notwithstanding anything in the preceding provisions of this Article, the driver of a vehicle shall move the same on the instruction of a police constable in uniform or a civil enforcement officer whenever such moving may be reasonably necessary for the purpose of preventing obstruction.
- 5. Nothing in the foregoing provisions of this Article shall be taken as authorising anything which would be a contravention of any regulations made or having effect as if made under section 25 of the Act of 1984.
- 6. Nothing in this Order shall amount to a contravention of any of the provisions of this Order insofar as it is done with the permission of or at the direction of a police constable in uniform.
