(AMENDMENT) ORDER 2003

SOUTH HAMS DISTRICT COUNCIL ("the Council") in exercise of their powers under sections 35 (1) (3) and (3A) and Paragraph 27 of the Ninth Schedule to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, with the consent of Devon County Council in accordance with Section 39(3) of the Act, and after consulting the Chief Officer of Police in accordance with Paragraph 20 of the Ninth Schedule to the Act, hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the _____ 2003 and may be cited as the District of South Hams (Off-Street Parking Places)(Amendment) Order 2003.

2. Interpretation

Interpretation of this Order shall be as provided for in Article 2 of the District of South Hams (Off-Street Parking Places) Order 1999 ("the Principal Order").

3. Amendment

The Principal Order shall be amended by:-

- (a) The deletion of the Schedule thereto, and its substitution by the Schedule to this Order;
- (b) Introducing overnight charging from 6pm to 8am in relation to the following Car Parks:
 - (i) Kingsbridge – Fore Street; Cookworthy Road; Quay Car Park; Castle Market Car Park (high season and high season – coaches);

- (ii) Salcombe – Creek Car Park; Shadycombe; Whitestrand; North Sands and Creek Coach Park
 - (iii) Hope Cove – Sunbay Layby
 - (iv) Dartmouth – Mayors Avenue; Coronation Park; Dartmouth Castle
 - (v) Totnes – Victoria Street; Old Market Car Park; Longmarsh and Longmarsh Extension; Steamer Quay; Civic Hall and Heaths Nursery
 - (vi) Torcross – Tank Car Park and Village Layby
 - (vii) Slapton – The Memorial Car Park and Strete Gate Car Park
 - (viii) Bigbury on Sea
- (c) The extension of the parking restrictions in relation to the following Car Parks-
- (i) Coronation Park, Dartmouth
 - (ii) Heathway 1 Car Park
 - (iii) Steamer Quay Car Park, Totnes
 - (iv) Torcross Village Layby (high season)
 - (v) Torcross Village Layby (low season)
 - (vi) Poundwell Meadow and overflow, Modbury
- (d) To include parking restrictions for the following Car Parks:
- (i) South Dartmoor Leisure Centre
 - (ii) Strete Gate Ice Cream Vendor's area
 - (iii) East Portlemouth
 - (iv) Whitestrand and Chapel End Slipways, Salcombe
 - (v) The Quay Slipway, Kingsbridge
- (e) To increase the reserved season (April to September) charge for Creek Car Park and Creek Boat Park, Salcombe from £265.00 to £512.00
- (f) To introduce a Monthly Residents Pass at a cost of £45.00 and a Six Monthly Residents Pass at a cost of £120.00 (no pro rata purchases to be allowed)

- (g) To discontinue refunds on any purchases of the Residents Passes, Weekly Tickets or the Annual Leisure And Commuter Users Pass
- (h) To increase the price of the "Go" passes from £30.00 to £40.00
- (i) The "Go" pass will no longer be valid in the Quay Car Park, Kingsbridge
- (j) The Annual Leisure and Commuter Users Pass will no longer be valid in the following Car Parks:
 - (i) Poundwell Meadow Car Park, Modbury
 - (ii) Quay Car Park, Kingsbridge
- (k) The Annual Leisure and Commuter Users Pass will be valid only in the following Car Parks:
 - (i) The Pavilion Car Park, Totnes
 - (ii) Longmarsh, Totnes
 - (iii) Leonards Road, Ivybridge
 - (iv) The Memorial Car Park, Slapton
 - (v) Torcross Layby
 - (vi) Park and Ride (excluding bus service), Dartmouth
 - (vii) Cattle Market, Kingsbridge
 - (viii) Poundwell Meadow Overflow, Modbury
- (l) The amendment of Clause 3 ("Use of Land and Parking Place") as follows:
 - (i) To add a new sub clause (iv) "no lorries, coaches, caravans, motor caravans, trailers or large vehicles in excess of 4.5 metres to be allowed unless stated otherwise"
 - (ii) To add a new sub clause (v) "no persons shall without the express permission of the Council undertake any commercial activity within any parking place or use any commercial vehicle to undertake such activities"

(iii) to add a new sub clause (vi) "no persons shall undertake any repairs or maintenance of vehicles, boats or any other items that are left in a parking place without express permission of the Council"

(m) The amendment of Clause 4(v)(a) namely:

"The parking ticket must be attached in a conspicuous position, namely the front windscreen of the vehicle in respect of which it has been issued"

(n) The amendment of Clause 13 of the Order by adding a new sub clause (iii) "no overnight parking without the express permission of the Council in all non fee paying car parks and areas"

(o) The amendment of Clause 22(ii) of the Order as follows:

All references to £50.00 be changed to £75.00

(p) Introducing a parking charge at the Park and Ride, Dartmouth which excludes the cost of the bus service to operate all year round and twenty four hours per day
