**SOUTH HAMS DISTRICT COUNCIL** ("the Council") in exercise of its powers under sections 35 (1) (3) and (3A) and Paragraph 27 of the Ninth Schedule to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, with the consent of Devon County Council in accordance with Section 39(3) of the Act, and after consulting the Chief Officer of Police in accordance with Paragraph 20 of the Ninth Schedule to the Act, hereby makes the following Order:-

1. **Commencement and Citation**

This Order shall come into operation on the 25<sup>th</sup> March 2006 and may be cited as the District of South Hams (Off-Street Parking Places)(Amendment) Order 2006.

2. **Interpretation**

Interpretation of this Order shall be as provided for in Article 2 of the District of South Hams (Off-Street Parking Places) Order 1999 ("the Principal Order").

3. **Amendment**

The Principal Order shall be amended by:-

- (a) The deletion of the Schedule thereto, and its substitution by the Schedule to this Order;
- (b) (i) To the definitions contained in Section 2(2) of the Principal Order is added the following:  
High Season means 25<sup>th</sup> March to 31<sup>st</sup> October inclusive in any year  
Low Season means 1<sup>st</sup> November to 24<sup>th</sup> March inclusive in any year  
(ii) To the definition of "Parking Bay" in Section 2(2) of the Principal Order is added the following:  
"For the avoidance of doubt, any area of a Parking Place which is hatched or cross-hatched by markings is not a Parking Bay."
- (c) Increasing the charge for the Leisure Permit and the Go Pass Permit from £50.00 to £51.50
- (d) To increase the charge for the use of Totnes Market Square from £100 to £103 per day and to increase the charge for the use of Kingsbridge Quay Square from £200 to £206 per day. These charges may be applied pro rata.
- (e) Increasing the charge for the Commuter Permit from £125.00 to £130.00
- (f) Increasing the charge for the Annual Parking Permit from £250.00 to £260.00
- (g) Increasing the charge for the 6 month Parking Permit from £150.00 to £155.00

- (h) Increasing the charge for the One Month Parking Permit from £50.00 to £52.00
- (i) Increasing the charge for the weekly ticket (7 days consecutive) from £25.00 to £26.00
- (j) Increasing the charge for the Annual Reserved Permit from £700.00 to £720.00
- (k) Increasing the charge for the Aveton Gifford Car and Boat Park 12 Month Permit from £100.00 to £103.00
