

THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA)
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002)
VARIATION ORDER (No.4) 2004

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 2nd February 2004 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) Variation Order (No.4) 2004
2. For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 Order shall have effect as though :-

- (a) The following entry in Part 1 of Schedule 33 "Restricted Waiting 8.00 am – 6.00 pm, Full Week, Waiting Limited to 1 Hour, Return Prohibited within 1 Hour" was deleted: -

Oxenholme Road	East Side	From a point 109 metres north west and northwards of the centre of Oxenholme Road Railway Bridge in a northerly direction for a distance of 61 metres

and replaced with the following: -

Oxenholme Road	East Side	From a point 109 metres north west and northwards of the centre of Oxenholme Road Railway Bridge in a northerly direction for a distance of 45 metres

- (b) The following were added to Part 1 of Schedule 52 "No Waiting At Any Time": -

Oxenholme Road	North Side	From a point 11 metres north west of the centre of Oxenholme Railway Bridge in an easterly and north easterly direction to the entrance road to Oxenholme Station.

✓ Oxenholme Road	South Side	From a point 11 metres north west of the centre of Oxenholme Road Railway Bridge in an easterly and north easterly direction to a point 5 metres east of a point opposite the western boundary of High Park Lodge.
✓ Oxenholme Road	East Side	From a point 154 northwest and northwards of the centre of Oxenholme Road Railway Bridge northwards for a distance of 17 metres.
✓ Helmside Road	West Side	From a point 53 metres north east of the centre of its junction with Helmside Gardens northeast to its junction with Oxenholme Road.
✓ Helmside Road	East Side	From a point 73 metres northeast of the Centre of its junction with Helmside Gardens northeast for a distance of 20 metres.
✓ Helmside Road	East Side	From a point 113 metres northeast of the centre of its junction with Helmside Gardens northeast to its junction with Oxenholme Road.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
