

THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA)
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002)
VARIATION ORDER (HELMSIDE ROAD, KENDAL) 2006

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 13th March 2006 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) Variation Order (Helmside Road, Kendal) 2006
2. For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 Order shall have effect as though: -
 - (a) The following entries were added to Schedule 52 Part 1 Kendal "No Waiting At Any Time": -

STREET NAME	SIDE OF STREET	RESTRICTED LENGTH
Helmside Road	West side	From a point 49 metres southwest of the centre of its junction with Hill Place northeastwards to its junction with Oxenholme Road
Helmside Road	East side	From a point 52 metres southwest of the centre of its junction with Hill Place northeastwards for a distance of 27 metres
Helmside Road	East side	From a point 11 metres southwest of the centre of its junction with Hill Place northeastwards to a point 28 metres northeast of the centre of said junction
Helmside Road	East side	From a point 10 metres southwest of the centre of its junction with Helmside Gardens northeastwards to a point 17 metres northeast of the centre of said junction
Helmside Gardens (Leg running in a northwest to southeast direction from Helmside Road)	Both Sides	The full length of the leg between Helmside Road and the leg running southwest-northeast

B6254 Oxenholme Road	North Side	From the entrance road to Oxenholme Station in an easterly direction to its junction with Hayclose Lane.

B6254 Oxenholme Road	South Side	From a point 5 metres east of a point opposite the western boundary of High Park Lodge in an easterly direction to its junction with Helm Lane

(b) The following entry in Schedule 52 Part 1 Kendal "No Waiting At Any Time" was deleted in its entirety: -

STREET NAME	SIDE OF STREET	RESTRICTED LENGTH
Helmside Road	West side	From a point 53 metres north east of the centre of its junction with Helmside Gardens north east to its junction with Oxenholme Road.

(c) The following was added as Schedule 35 Part 1 Kendal "Parking Place Restricted Waiting 8.00 am – 10.00 pm Full Week, Waiting Limited to 2 Hours, Return Prohibited within 2 Hours": -

Helmside Road	WL 2 Hours, RPW 2 Hours	East	From a point 17 metres northeast of the centre of its junction with Helmside Gardens, in a northeasterly direction for a distance of 36 metres	Zone E

Zone E consists of Even Nos 72 to 112 Helmside Road, Odd Nos 111 to 159 Helmside Road

(d) Article 70 was amended to read: -

70. Save as provided in Article 87, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a parking attendant, cause or permit any vehicle to wait between the hours of 8.00 am and 10.00 pm on any day, in the lengths of road or sides of road specified in Schedule 35: -

- (1) for a longer period than 2 hours; or
- (2) if a period of less than 2 hours have elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road.

(e) The following was added to Article 2: -

“Zone E in relation to Kendal means: -

All of Helmside Gardens, Even Nos 72 to 112 Helmside Road and Odd Nos 111 to 159 Helmside Road”.

(f) The following was added to Schedule 87 Part 1 Kendal “Prohibition of Motor Vehicles Except for Access”: -

Helmside Gardens	Prohibition of Motor Vehicles	Both Sides	Its Full Length

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
