

THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA)  
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002)  
VARIATION ORDER (LOW FELLSIDE, KENDAL) 2006

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 22 May 2006 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) Variation Order (Low Fellside, Kendal) 2006
2. For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 Order shall have effect as though: -
  - (a) The following were added as Articles 124E and 124F: -

124E. Save as provided in Article 124F of this Order, no person shall cause or permit any vehicle to proceed in the length of road specified in Schedule 89C to this Order.

124F Nothing in Article 124E to this Order shall apply to pedal cycles.
  - (b) The following was added as Schedule 89C: -

**SCHEDULE 89C – KENDAL**

**Prohibition of All Vehicles Except for Pedal Cycles**

<u>Town/Village</u>	<u>Street Name</u>	<u>Restricted Length</u>
Kendal	U808 Low Fellside	That length of Low Fellside, Kendal, from a point 59 metres south of the centre of its junction with Fountain Brow, southwards for a maximum distance of 10 metres.

- (c) The following entry in Schedule 3A "Parking places restricted to waiting 8am – 6pm full week. Waiting limited to 30 minutes, return prohibited within 30 minutes" was deleted (as only part was implemented on the ground) and is therefore re-enacted in its entirety:-

Street Name	Restriction	Side of Street	Restricted Length	Exemption
Low Fellside	PPWL 30 mins RPW 30 mins	East	From a point 180 metres north of the centre of its junction with Allhallows Lane/Beast Banks in a southerly direction to a point 64 metres north of the centre of its junction with Middle Lane.	All in Zone C

4. The County of Cumbria (Low Fellside, Kendal) (Prohibition of Motor Vehicles Except for Access and Prohibition of Waiting) Order 2002 is hereby revoked in its entirety.
5. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
