

THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKE LAND AREA)
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002)
VARIATION ORDER (KIRKBY LONSDALE AND DEVILS BRIDGE,
CASTERTON PARISH) 2006

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 3rd April 2006 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) Variation Order (Kirkby Lonsdale and Devils Bridge, Casterton Parish) 2006
2. For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 Order shall have effect as though: -

152A. No person shall cause or permit any vehicle, other than a motor cycle, to stop or remain at rest at any time on a Saturday, Sunday or a Bank Holiday, in the lengths of road specified in Schedule 111A to this Order.

152B. On all days except Saturdays, Sundays and Bank Holidays, any vehicle may park in the lengths of road specified in Schedule 111A to this Order.
