

THE COUNTY OF CUMBRIA (VARIOUS ROADS, GRANGE-OVER-SANDS)  
(CONSOLIDATION AND PROVISION OF TRAFFIC REGULATIONS) (ORDER 2005)  
VARIATION ORDER (NO.1) 2007

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 29 January 2007 and may be cited as The County of Cumbria (Various Roads, Grange-Over-Sands) (Consolidation and Provision of Traffic Regulations) (Order 2005) Variation Order (No.1) 2007
2. For the purposes of this Order the expression “the 2005 Order” shall mean The County of Cumbria (Various Roads, Grange-Over-Sands) (Consolidation and Provision of Traffic Regulations) Order 2005
3. The 2005 Order shall have effect as though: -
  - (a) The following was added to Schedule 1 “Waiting Limited to 1 Hour, No Return Within 1 Hour, 9 am to 6 pm”: -

<u>Road Number</u>	<u>Road Name</u>	<u>Side</u>	<u>Length</u>
U5840	Nutwood Crescent	South	From a point 16m south west of the centre of its junction with Windermere Road southwestwards for a distance of 9m (measured along the kerb line)

C5042	Grange Fell Road	North	From a point 23m west of the centre of its junction with Vicarage Close to a point 12m east of the centre of its junction with Cragg Drive
U5679	Kents Bank Road	West	From a point 116m south of the centre of its junction with Albert Road southwards for a distance of 26m.
