

THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA)
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002)
VARIATION ORDER (HELMSIDE ROAD, KENDAL) 2009

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 7 September 2009 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) Variation Order (Helmside Road, Kendal) 2009
2. For the purposes of this Order the expression “the 2002 Order” shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 Order shall have effect as though:
 - (a) The following entries were deleted from Schedule 35 Part 1 – Kendal “Restricted Waiting, 8 am – 10 pm, Full Week, Waiting Limited to 2 Hours, Return Prohibited within 2 Hours”: -

<u>Street Name</u>	<u>Restriction</u>	<u>Side of Street</u>	<u>Restricted Length</u>	<u>Exemption</u>
Helmside Road	WL 2 Hours, RPW 2 Hours	East	From a point 28 metres north east of the centre of its junction with Hill Place to a point 10 metres south west of the centre of its junction with Helmside Gardens	Zone E
Helmside Road	WL 2 Hours, RPW 2 Hours	East	From a point 17 metres north east of the centre of its junction with Helmside Gardens, in a north-easterly direction for a distance of 36 metres.	Zone E

- (b) The following entries were added to Schedule 35 Part 1 – Kendal “Restricted Waiting, 8 am – 10 pm, Full Week, Waiting Limited to 2 Hours, Return Prohibited within 2 Hours”:-

<u>Street Name</u>	<u>Restriction</u>	<u>Side of Street</u>	<u>Restricted Length</u>	<u>Exemption</u>
Helmside Road	WL 2 Hours, RPW 2 Hours	East	From a point 46 metres north east of the centre of its junction with Hill Place to a point 38 metres south west of the centre of its junction with Helmside Gardens	Zone E
Helmside Road	WL 2 Hours, RPW 2 Hours	East	From a point 17 metres north east of the centre of its junction with Helmside Gardens, in a north-easterly direction for a distance of 27 metres.	Zone E

- (c) The following entries in Schedule 52 Part 1 – Kendal “No Waiting At Any Time” were deleted:-

<u>Street Name</u>	<u>Restriction</u>	<u>Side of Street</u>	<u>Restricted Length</u>
Helmside Road	NWAAT	East	From a point 73 metres north east of the centre of its junction with Helmside Gardens north east for a distance of 20 metres.
Helmside Road	NWAAT	East	From a point 10 metres south west of the centre of its junction with Helmside Gardens northeastwards to a point 17 metres north east of the centre of the said junction.
Helmside Road	NWAAT	East	From a point 52 metres southwest of the centre of its junction with Hill Place northeastwards for a distance of 27 metres.

(d) the following entries were added to Schedule 52 Part 1 Kendal “No Waiting At Any Time”:-

<u>Street Name</u>	<u>Restriction</u>	<u>Side of Street</u>	<u>Restricted Length</u>
Helmside Road	NWAAT	East	From a point 68 metres north east of the centre of its junction with Helmside Gardens north east for a distance of 25 metres.
Helmside Road	NWAAT	East	From a point 14 metres south west of the centre of its junction with Helmside Gardens northeastwards to a point 17 metres north east of the centre of the said junction.
Helmside Road	NWAAT	East	From a point 87 metres southwest of the centre of its junction with Hill Place northeastwards for a distance of 62 metres.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
