

**THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA)**  
**(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002)**  
**(PYE LANE/SWAN LANE, GRASMERE AND ELLERTHWAITE ROAD,**  
**WINDERMERE) VARIATION ORDER 2009**

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

1. This Order shall come into operation on 18 May 2009 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) (Pye Lane/Swan Lane, Grasmere and Ellerthwaite Road, Windermere) Variation Order 2009
2. For the purposes of this Order the expression “the 2002 Order” shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 Order shall have effect as though:-
  - (a) The following entries were added to Schedule 19 Part 1, Miscellaneous – “Parking Place, Waiting Limited to 2 Hours, Return Prohibited within 2 Hours 9.00 am – 6.00 pm Full Week”:-

| Grasmere              |                             | Pye Lane                  | PP, WL 2 HOURS<br>RPW 2 HOURS | West               | From a point 117m south of its junction with the A591 southwards for a distance of 10m. |

- (b) The following entries were added to Schedule 52 Part 4, Windermere and Bowness-on-Windermere - “No Waiting At Any Time”:-

| Windermere                 | Ellerthwaite Road         | NWAAT                     | East               | From a point 24m north of the centre of its junction with Woodland Road northwards for a distance of 26m. |

- (c) The following entries were added to Schedule 52 Part 5, Miscellaneous - “No Waiting At Any Time”: -

| Grasmere                   | Pye Lane                  | NWAAT                     | West               | From the centre of its junction with the A591 southwards for a distance of 83m.   |
| Grasmere                   | Pye Lane                  | NWAAT                     | West               | From a point 95m south of the centre of its junction with the A591 southwards for a distance of 22m.                                |
| Grasmere                   | Pye Lane                  | NWAAT                     | West               | From a point 117m south of the centre of its junction with the A591 southwards for a distance of 121m.                              |
| Grasmere                   | Pye Lane                  | NWAAT                     | East               | From its junction with the A591 to its junction with the B5287 Swan Lane.   |
| Grasmere                   | B5287 Swan Lane           | NWAAT                     | Both               | From its junction with the A591 southwestwards to a point 10m southwest of the eastern boundary wall of its junction with Pye Lane. |

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
