

THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA)
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002)
(VARIOUS ROADS, KIRKBY LONSDALE) VARIATION ORDER 2011

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 7 March 2011 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) (Various Roads, Kirkby Lonsdale) Variation Order 2011
2. For the purposes of this Order the expression “the 2002 Order” shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 Order shall have effect as though: -
 - (a) the following were added to Schedule 52 Part 5 – Miscellaneous “No Waiting At Any Time”:-

Kirkby Lonsdale	Kings Arms Yard	East	From a point 47m north of the north side of its junction with New Road (building line) northwards for a distance of 51m.
Kirkby Lonsdale	New Road B6446	Northeast	From the east side of its junction with Mitchelgate to a point 53m northwest of the west side of its junction with Dodgson Croft.
Kirkby Lonsdale	Biggins Road	Northwest	From a point 32m southwest of the eastern gable wall of Tollgate Cottage southwest-wards for a distance of 88m.
Kirkby Lonsdale	Biggins Road	Southeast	From a point 32m southwest of the eastern gable wall of Tollgate Cottage southwestwards for a distance of 98m.
Kirkby Lonsdale	Biggins Road	Southeast	From a point 135m southwest of the eastern gable wall of Tollgate Cottage southwestwards for a distance of 32m.
