

THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA)
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002)
(ULVERSTON – NO. 5) VARIATION ORDER 2012

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 26 November 2012 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) (Ulverston – No. 5) Variation Order 2012
2. For the purposes of this Order the expression “the 2002 Order” shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 Order shall have effect as though: -
 - (a) The following entries were added to “Schedule 52, Part 3, Ulverston – No Waiting At any Time”: -

U5703 Central Drive	NWAAT	North East	From a point 15 metres north west of the northern side of its junction with Rowan Avenue south easterly for a distance of 36 metres.

U5707 The Drive	NWAAT	North West	From a point 10 metres south west of the south western side of its junction with Woodland Road in a north easterly direction for a distance of 28 metres.

U5729 Beech Bank	NWAAT	South	From a point 5 metres west of the western side of its junction with Sea View in an easterly direction for a distance of 16 metres.
U5729 Sea View	NWAAT	Both	From the centre of its junction with Beech Bank in a southerly direction for a distance of 5 metres.

- (c) The following was added as "Schedule 51 Part 2 – Ulverston – Restricted Waiting, 8.00 am – 6 pm, Monday to Saturday": -

U5711 Lightburn Road	North	From a point 20 metres west of the centre of its junction with Brogden Street to a point 14 metres east of the centre of its junction with Victoria Road.	All in Zone C

- (d) The following was added as Article 86C: -

86C. Save as provided in Article 87, no person shall, except upon the direction or with the permission of a Police Constable in uniform, cause or permit any vehicle to wait between the hours of 8 am and 6 pm, on a Monday to Saturday inclusive, in the lengths of road or sides of road specified in Schedule 51C: -

- (a) for a longer period than 2 hours; or
- (b) if a period of less than 2 hours has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road.

- (e) Article 92 was amended to read: -

92. (1) Any resident whose normal residence is at premises the postal address of which is specified in columns 5 and/or 6 of Schedules 28 to 51C inclusive of this Order, as appropriate, who is the owner of a vehicle not exceeding 72" (1.83m) in height, being either a passenger vehicle, a goods vehicle or motor cycle with sidecar attached thereto, may apply to the Council for the issue of a permit for the leaving of that vehicle in the lengths of road or sides of road referred to in Articles 63 to 86C inclusive of this Order, any such application shall be made on a form issued by the Council and obtainable from such office as the Council shall require, and shall include the particulars and information required by such form.

(2) The Council may require an applicant for a permit to produce to an Officer of the County Council such evidence in respect of the application as they may reasonably require to verify any particulars or information given to them.

(3) the Council, upon being satisfied that an applicant is a person whose normal residence is at premises the postal address of which is specified in columns 5 and/or 6 of Schedules 28 to 51C of this Order, and is the owner of a vehicle of a class specified in paragraph (1) of this Order, may issue to that applicant one permit exempting the vehicle from the time limit in the lengths of road or sides of road specified in Schedule 28 to 51C inclusive to this Order.

(f) Article 94(3)(a) was amended to refer to Schedule 28 to 51C inclusive.

(g) Article 95 was amended to refer to Schedules 28 to 51C inclusive.

(h) The following was added to Schedule 53 Part 4 – Ulverston – “No Waiting, 8 am – 6 pm, Full Week”:-

B5281 Soutergate	West	From a point 50 metres north of its junction with Mill Street (north side) in a northerly direction for a distance of 23 metres.

(i) The following entry in Schedule 4, Part 3 – Ulverston “Parking Place, Restricted Waiting, 8 am – 6 pm, Monday to Saturday inclusive”, Waiting Limited to 1 Hour Return Prohibited within 1 Hour”, was deleted in its entirety:-
