

THE COUNTY OF CUMBRIA (VARIOUS ROADS, GRANGE-OVER-SANDS)  
(CONSOLIDATION AND PROVISION OF TRAFFIC REGULATIONS) (ORDER 2005)  
VARIATION ORDER (NO.4) 2013

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 16 December 2013 and may be cited as The County of Cumbria (Various Roads, Grange-Over-Sands) (Consolidation and Provision of Traffic Regulations) (Order 2005) Variation Order (No.4) 2013
2. For the purposes of this Order the expression "the 2005 Order" shall mean The County of Cumbria (Various Roads, Grange-Over-Sands) (Consolidation and Provision of Traffic Regulations) Order 2005
3. The 2005 Order shall have effect as though: -

(a) The following entry in Schedule 1 "Waiting Limited to 1 Hour, No Return within 1 hour, 9 am to 6 pm", was deleted in its entirety: -

ROAD NUMBER	ROAD NAME	SIDE	RESTRICTED LENGTH
U5679	Kents Bank Road	West	From a point 21 metres north of the centre of its junction with Fernleigh Road in a northerly direction to the south side of its junction with Laundry Hill.
U5737	Cross Street	North	From a point 13 metres west of the centre of its junction with Park Road westwards for a distance of 25 metres to the east side of its junction with Kents Bank Road.

(b) The following entry in Schedule 2 "No Waiting At Any Time" was deleted in its entirety: -

ROAD NUMBER	ROAD NAME	SIDE	RESTRICTED LENGTH
B5277	Main Street	East	From a point 21m north of the centre of its junction with Main Street car park exit road southwards to a point 32m north of the southern side of its junction with the northern end of Back Main Street.

- (c) The following entries in Schedule 3 "No Waiting, 8 am to 6 pm" were deleted in their entirety: -

B5277	Main Street	South	From the centre of its junction with Kents Bank Road in an easterly direction for a distance of 7 metres.

C5042	Grange Fell Road	Both	From its junction with Kents Bank Road in a westerly direction to its junction with Fernleigh Road.
U5679	Kents Bank Road	West	From the south side of its junction with Grange Fell Road and Main Street in a south-westerly direction for a distance of approximately 96 metres to a point 18 metres south of the centre of its junction with Albert Road.
U5679	Kents Bank Road	East	From the south side of its junction with Main Street and Grange Fell Road in a south-westerly direction for a distance of approximately 40 metres to a point 42 metres north of the centre of its junction with Albert Road.
U5737	Cross Street	North	From a point 9 metres west of the centreline of Park Road westwards for a distance of 4 metres.
B5277	Lindale Road	North	From the centre of its junction with Main Street and Windermere Road for a distance of 89 metres in an easterly direction.

	Fernleigh Road	South East	From the south east side of its junction with Grange Fell Road in a south westerly direction for a distance of 27 metres.
C5042	Grange Fell Road	South West	From the south west side of its junction with Kents Bank Road in a north westerly direction to the south east side of its junction with Fernleigh Road.
C5042	Grange Fell Road	North East	From the north west side of its junction with Pig Lane in a north westerly direction for a distance of 15 metres.
C5042	Grange Fell Road	North East	From the south east side of its junction with Hardcragg Way in a south easterly direction for a distance of 10 metres.
U5679	Kents Bank Road	South East	From the south east side of its junction with Main Street in a south westerly direction for a distance of 24 metres.
U5679	Kents Bank Road	North West	From the north west side of its junction with Main Street in a south westerly direction for a distance of 15 metres.
U5737	Cross Street	North	From the north side of its junction with Park Road in north westerly direction for a distance of 9.5 metres.
	Riggs Close	Both	From its junction with Lindale Road northwards for its entire length, including turning head.
B5277	Lindale Road	North	From a point 10 metres east of the east side of its junction with Riggs Close in a westerly direction to a point 10 metres west of the west side of its junction with Riggs Close.

- (f) The following entries were added to Schedule 3 "No Waiting, 8 am to 6 pm": -

ROAD NUMBER	ROAD NAME	SIDE	RESTRICTED LENGTH
U5678	Fernleigh Road	South East	From the north side of its northern junction with Rockland Road in a northerly direction to a point 27 metres south west of the south east side of its junction with Grange Fell Road.
U5679	Kents Bank Road	North West	From a point 15 metres south of the south side of its junction with Grange Fell Road in a south westerly direction for a distance of 81 metres.
B5277	Lindale Road	North	From the east side of its junction with Windermere Road in an easterly direction to a point 10 metres west of the west side of its junction with Riggs Close.

- (g) Articles 4 and 5 were replaced with the following: -

Restriction of Waiting

4. (A) Save as provided in Article 5, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a parking attendant, cause or permit any vehicle to wait between the hours of 9.00 am and 6.00 pm each day, in any parking place specified in Schedule 1 of this Order: -
- (1) for a longer period than 1 hour; or
  - (2) if a period of less than 1 hour has elapsed since the termination during the said hour of the last period of waiting (if any) by that vehicle on the same length of road.
- (B) Save as provided in Article 5, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a parking attendant, cause or permit any vehicle to wait between the hours of 9.00 am and 6.00 pm on a Monday to Saturday inclusive, in any parking place specified in Schedule 1A of this Order: -
- (1) for a longer period than 1 hour; or
  - (2) if a period of less than 1 hour has elapsed since the termination during the said hour of the last period of waiting (if any) by that vehicle on the same length of road.

## Exemptions

5. (1) Nothing in Article 5 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of road or sides of road referred to therein if the vehicle is:-
- (a) waiting only so long as is necessary to enable a person to board or alight from the vehicle or to enable goods or merchandise to be loaded onto or unloaded from the vehicle;
  - (b) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
  - (c) a vehicle used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties;
  - (d) waiting to enable it to be used in connection with the removal of any obstruction to traffic;
  - (e) being used by statutory undertakers or their contractors in connection with the laying erection alteration or repair in or in land adjacent to that length of road of any sewer or of any main pipe or apparatus for the supply of water gas or electricity or of any telecommunications apparatus as defined in Schedule 2 of the Telecommunications Act 1984;
- (2) A disabled person's vehicle which displays in the relevant position a disabled person's badge shall be exempt from compliance with any limitation of time during which a vehicle may be left in the lengths of road or sides of road specified in Article 4 to this Order.
- (h) Schedule 1A attached was added as Schedule 1A thereto.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

U5679	Kents Bank Road	West	From a point 18 metres north of the north side of its junction with Fernleigh Road in a northerly direction to the south side of its junction with Laundry Hill.
U5737	Cross Street	North	From a point 9.5 metres west of the north side of its junction with Park Road westwards for a distance of 25 metres.
