

THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA)
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002)
(VARIOUS ROADS, KENDAL, CROOKLANDS, SANDGATE AND CARTMEL)
VARIATION ORDER 2014

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

1. This Order shall come into operation on 24 February 2014 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) (Various Roads, Kendal, Crooklands, Sandgate and Cartmel) Variation Order 2014
2. For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 shall have effect as though: -
 - (a) The following entries were added to Schedule 4 Part 1 Kendal "Parking Place Restricted Waiting 8.00 am – 6.00 pm Monday to Saturday inclusive, Waiting Limited to 1 Hour, Return Prohibited within 1 Hour": -

- (e) Articles 123 and 124 were amended to read: -

Prohibition of Motor Vehicles – Except for Access

- 123 Save as provided in Article 124, no person shall cause or permit any motor vehicle to proceed in the lengths of road specified in Schedule 89 to this Order.
- 124 Nothing in Article 123 to this Order shall apply to motor vehicles being used: -
- (a) for Police, Fire Brigade or Ambulance purposes; or
- (b) for the conveyance of goods, merchandise or persons to or from premises situated on or adjacent to the said lengths of road.
- (f) The heading to Schedule 89, Part 1 and Part 2, were amended to read “Prohibition of Motor Vehicles - Except for Access”.
- (g) The following was added as Schedule 89 Part 3 Kendal “Prohibition of Motor Vehicles – Except for Access”:-
