

THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKE LAND AREA)
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002)
(ULVERSTON – NO. 6) VARIATION ORDER 2014

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 3 March 2014 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) (Ulverston – No. 6) Variation Order 2014
2. For the purposes of this Order the expression “the 2002 Order” shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 Order shall have effect as though: -

(b) The following was added as Article 67A: -

67A. Save as provided in Article 87, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a civil enforcement officer, cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm, on a Monday, Tuesday, Wednesday and Friday (ie. except on Thursday and Saturdays being Market Days and on a Sunday), in the lengths of road or sides of road specified in **Schedule 32A: -**

- (1) for a longer period than 1 Hour; or
- (2) if a period of less than 1 Hour has elapsed since the termination during the said hour of the last period of waiting (if any) by that vehicle on the same length of road.

(c) The following was added as Schedule 32A: -

105A. that part of the road specified at Schedule 79A to this Order is authorised to be used, at any time, on any day, except Thursday and Saturdays, being market days, subject to Articles 106 and 107 as a parking place for a valid disabled person’s vehicle which displays a disabled person’s badge in a relevant position for a period not exceeding 3 hours, providing that, where a vehicle has left a parking place specified in Schedule 79A of this Order after waiting thereon, the driver thereof shall not within three hours after its leaving permit it to wait again upon that parking place.

- (i) Article 106(1) was amended to refer to Schedules 75 to 79A inclusive in place of 75 to 79.
- (j) Articles 107(1) and 107(2) were amended to refer to Articles 101 to 105A in place of 101 to 105.
- (k) The following was added as Schedule 79A Part 1 Ulverston to this Order: -

At all Times, 8 am – 5 pm, Thursdays & Saturdays

121. Save as provided in Article 122 of this Order, no person shall cause any motor vehicle to proceed along the lengths of road specified in Schedule 88 of this Order between the hours of 8 am and 5 pm, on a Thursday and Saturday.

(n) Article 122 was amended to read: -

122. Nothing in Article 121 of this Order shall apply so as to prevent any person from causing any vehicle to proceed along those roads referred to therein so long as that vehicle is necessarily being used:-
- (i) in connection with any building or demolition operations in or adjacent to that part of road;
 - (ii) in connection with the removal of any obstruction to traffic from that part of road;
 - (iii) in connection with the maintenance, improvement or reconstruction of that part of road; or
 - (iv) in connection with the laying erection alteration or repair in or adjacent to that part of road of any sewer or of any main pipe or apparatus for the supply of gas water or electricity or of any telegraphic lines or traffic sign or telecommunication apparatus;
 - (v) in the event of an emergency being dealt with by the Police, Fire or Ambulance Service;
 - (vi) for the purpose of loading or unloading goods to or from the vehicle to or from premises named as 5 Market Street, The Soup Dragon.
 - (vii) in actual use in connection with the removal of a coffin containing the remains of a deceased person to or from premises situate on or adjacent to that parking place;
 - (viii) by Market Traders as part of the Market Charter for the business of setting up and deconstructing their market stalls.

- (o) The following was added as a new replacement Schedule 88 "Prohibition of All Vehicles, 8 am – 5 pm, Thursdays and Saturdays": -
