(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002)
(BIRTHWAITE ROAD AND PHOENIX WAY, WINDERMERE)
VARIATION ORDER 2014

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

1. This Order shall come into operation on 22 December 2014 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) (Birthwaite Road and Phoenix Way, Windermere) Variation Order 2014
2. For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 Order shall have effect as though the following entries were added to Schedule 52 Part 4, Windermere and Bowness-on-Windermere - "No Waiting At Any Time": -

Town/Village	Street Name	Restriction	Side	Restricted Length
Windermere	Birthwaite Road	NWAAT	North	From its junction with the A5074 New Road for its entire length to its junction with the A592 Rayrigg Road.
Windermere	Birthwaite Road	NWAAT	South	From its junction with the A5074 New Road to a point 186 metres north-east of its junction with the A592 Rayrigg Road a distance of approximately 834 metres.

Windermere	Birthwaite Road	NWAAT	South	From its junction with the A592 Rayrigg Road in a north-easterly direction for a distance of 43 metres.
Windermere	Phoenix Way	NWAAT	East	From its junction with the A591 in a southerly direction for a distance of 86 metres.
Windermere	Phoenix Way	NWAAT	West	From its junction with the A591 in a southerly direction for a distance of 82 metres.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
