**THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA)**  
**(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002)**  
**(VICARAGE DRIVE, HILLSWOOD AVENUE AND WESTWOOD AVENUE, KENDAL)**  
**VARIATION ORDER 2015**

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

1. This Order shall come into operation on 13 April 2015 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) (Vicarage Drive, Hillswood Avenue and Westwood Avenue, Kendal) Variation Order 2015
2. For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 shall have effect as though: -

- (a) The following entries were added to Schedule 52 Part 1 Kendal "No Waiting At Any Time": -

<b><u>Street Name</u></b>	<b><u>Restriction</u></b>	<b><u>Side of Street</u></b>	<b><u>Restricted Length</u></b>
Hillswood Avenue	NWAAT	Both	From the northern side of its junction (intersection of kerb lines) with Vicarage Drive in a northerly direction for a distance of 12 metres
Vicarage Drive	NWAAT	North East	From a point 64 metres south east of the southern side of its junction (intersection of kerb lines) with Westwood Avenue in a south easterly direction for a distance of 46 metres
Vicarage Drive	NWAAT	North	From a point 14 metres west of the west side of its junction (intersection of kerb lines) with Hillswood Avenue in an easterly direction for a distance of 32 metres
Vicarage Drive	NWAAT	South West	From a point 13 metres north of the northern side of its junction (intersection of kerb lines) with Westwood Avenue in a south easterly direction for a distance of 149 metres
Westwood Avenue	NWAAT	Both	From the south western side of its junction (intersection of kerb lines) with Vicarage Drive in a westerly direction for a distance of 12 metres

- (b) The following entries were added to Schedule 60 Part 1 Kendal “No Waiting 8 am – 5 pm, Mon – Fri inclusive”:-

<u>Street Name</u>	<u>Restriction</u>	<u>Side of Street</u>	<u>Restricted Length</u>
Vicarage Drive	NW	North	From a point 35 metres east of the eastern side of its junction (intersection of kerb lines) with Vicarage Park Primary School vehicular entrance in a westerly direction for a distance of 134 metres

- (c) The following entry was deleted from Schedule 60 Part 1 Kendal “No Waiting 8 am – 5 pm, Mon – Fri inclusive”:-

<u>Street Name</u>	<u>Restriction</u>	<u>Side of Street</u>	<u>Restricted Length</u>
Vicarage Drive	NW	North	From a point 47m west of the centre of its junction with the school access extending in an easterly direction for a distance of 84m (measured along the kerb line)

- (d) The following was added as Article 88(20A):-

“between the hours of 9 am and 5 pm, on a Monday to Friday inclusive, between 1<sup>st</sup> September and 30<sup>th</sup> June inclusive in the lengths of road or sides of road specified in Schedule 71A of this Order”.

- (e) The following was added as Schedule 71A Part 1 Kendal “No Waiting 9 am – 4 pm, Mon – Fri, 1<sup>st</sup> September to 30<sup>th</sup> June inclusive”:-

<u>Street Name</u>	<u>Restriction</u>	<u>Side of Street</u>	<u>Restricted Length</u>
Vicarage Drive Cul-de-sac	NW	Both	On the north side from a point 51 metres from its junction (intersection of kerb lines) with Vicarage Drive around the entire cul-de-sac to a point on the south side 50 metres from its junction (intersection of kerb lines) with Vicarage Drive

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
