THE COUNTY OF CUMBRIA (VARIOUS ROADS, GRANGE-OVER-SANDS)  
(CONSOLIDATION AND PROVISION OF TRAFFIC REGULATIONS) (ORDER 2005)  
VARIATION ORDER (NO.5) 2015

1. The Cumbria County Council hereby give notice that on 19 June 2015 it made the above Order under Sections 1, 2, 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 of the Road Traffic Regulation Act 1984.
2. The Order will come into operation on 29 June 2015 and its effect will be to: -
  - (a) Retain the “Limited Waiting 1 hour, No Return within 1 hour, 9 am – 6 pm” parking bay which is 24 metres in length, on the west side of Kents Bank Road, Grange-over-Sands, but to
  - (b) Introduce a “Loading Only, 7 am – 9 am” restriction on 14m of the bay,  
  
so that the whole of the bay will be subject to limited waiting between 9 am and 6 pm but a 14 metre length will be dual purpose, ie. subject both to limited waiting between 9 am and 6 pm and for loading purposes only between 7 am and 9 am outside the proposed new Tesco development.

3. Full details of the Order, together with a plan showing the length of road concerned, a statement of the Council's reasons for making the Order and a copy of the Order being varied, may be inspected at Grange-over-Sands Library, Grange Fell Road, Grange (opening hours – Monday, Tuesday, Wednesday – 9.30 am – 5.00 pm, Thursday and Saturday – 9.30 am – 1pm, Friday 9.30 am – 5.00 pm) and the offices of the undersigned during normal working hours.
4. If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or any instrument made thereunder has not been complied with in relation to the Order, you may within six weeks of 19 June 2015 apply to the High Court for this purpose.

VARIATION ORDER (NO.5) 2015

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 29 June 2015 and may be cited as The County of Cumbria (Various Roads, Grange-Over-Sands) (Consolidation and Provision of Traffic Regulations) (Order 2005) Variation Order (No.5) 2015
2. For the purposes of this Order the expression "the 2005 Order" shall mean The County of Cumbria (Various Roads, Grange-Over-Sands) (Consolidation and Provision of Traffic Regulations) Order 2005
3. The 2005 Order shall have effect as though: -
  - (a) **The following was added as Part IVA – Loading Only Parking Place: -**

**PART IVA**

LOADING ONLY PARKING PLACES

- 15A. Save as provided in Article 15B to this Order, no person shall cause or permit any vehicle to wait between the hours of 7.00 am and 9.00 am on any day, in the lengths of road or sides of road specified in Schedule 6A to this Order UNLESS the vehicle is waiting for the purpose of loading or unloading.

Exemptions

- 15B. Nothing in Article 15A of this Order shall apply so as to render it unlawful for a person to cause or permit a vehicle to wait in the lengths of road specified therein if the vehicle is:-
- (a) being used by statutory undertakers or their contractors in connection with any building operation or demolition the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration or repair in or near the said parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984;
  - (b) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
  - (c) being used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties.

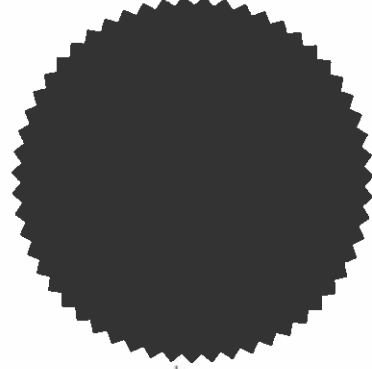
(b) Schedule 6A attached was added as Schedule 6A thereto.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
