

THE CITY OF SOUTHAMPTON (NORTHAM, BITTERNE MANOR & ITCHEN) (RESIDENTS' PARKING SCHEME) (AMENDMENT 1) ORDER 2018

Southampton City Council in exercise of its powers under Sections 1, 2, 4, 45, 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

1 This Order shall come into operation on 11th May 2019 and may be cited as The City of Southampton (Northam, Bitterne Manor & Itchen) (Residents' Parking Scheme) (Amendment 1) Order 2018.

INTERPRETATION


- 2 In this Order:
 - (i) "Principal Order 1" shall mean The City of Southampton (Northam, Bitterne Manor & Itchen) (Residents' Parking Scheme) Order 2008.
 - (ii) "Principal Order 2" shall mean The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011
 - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

- 3 The contents of Schedule 1 shall be deleted from Schedule 2.01 to the Principal Order 1
- 4 The contents of Schedule 2 shall be deleted from Schedule 2.01 to the Principal Order 2
- 5 The contents of Schedule 3 shall be added to Schedule 2.01 to the Principal Order 1
- 6 The contents of Schedule 4 shall be deleted from Schedule 2.07 to the Principal Order 1
- 7 The contents of Schedule 5 shall be added to Schedule 5.09 to the Principal Order 1
- 8 The contents of Schedule 6 shall be added to Schedule 5.09 to the Principal Order 1
