

# THE CITY OF SOUTHAMPTON (VARIOUS ROADS) (PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT 41) ORDER 2015

Southampton City Council in exercise of its powers under Sections 1, 2, 4, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

#### **CITATION**

1 This Order shall come into operation on 6<sup>th</sup> February 2017 and may be cited as The City of Southampton (Various Roads) (Prohibition and restriction of waiting) (Amendment 41) Order 2015.

#### INTERPRETATION

- 2 In this Order:
  - (i) "Principal Order" shall mean The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Order 2011, as amended.
  - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

### **AMENDMENTS**

3 The contents of schedule 2 shall be inserted into schedule 2.0.1 of the Principal Order.

Lower Brownhill	South-	From the south-western kerbline of Lower Brownhill Road (spur) south-
Road	east	westwards for 25m
Lower Brownhill	South-	From 42m north-east of the north-eastern kerbline of Colne Avenue north-
