

THE CITY OF SOUTHAMPTON (VARIOUS ROADS) (MOVEMENT RESTRICTIONS) (AMENDMENT 20) ORDER 2016

Southampton City Council in exercise of its powers under Sections 1, 2, 4, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

1 This Order shall come into operation on 20th February 2017 and may be cited as The City of Southampton (Various Roads) (Movement Restrictions) (Amendment 20) Order 2016.

INTERPRETATION

- 2 In this Order:
 - (i) "Principal Order 1" shall mean the City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010, as amended.
 - (ii) "Principal Order 2" shall mean the City of Southampton (Residents Parking) (Zones 1 12 & 16) Order 2014, as amended.
 - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.


ADDITION/AMENDMENT OF SCHEDULES
