



**THE CITY OF SOUTHAMPTON  
(WAITING RESTRICTIONS AMENDMENT) (PART 2) ORDER 2017**

Southampton City Council (hereinafter called "the Council") in exercise of its powers under sections 1, 2, 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

**CITATION**

- 1** This Order shall come into operation on 5<sup>th</sup> June 2017 and may be cited as The City of Southampton (Waiting Restrictions Amendment) (Part 2) Order 2017.

**INTERPRETATION**

- 2** In this Order:
  - (i) "Principal Order 1" means the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
  - (ii) "Principal Order 2" means the City of Southampton (Residents Parking) (Zones 1–12 & 16) Traffic Regulation Order 2014, as amended.
  - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
- 3** The contents of schedule 1 shall be deleted from schedule 2.01 of Principal Order 1.
- 4** The contents of schedule 2 shall be inserted into schedule 2.01 of Principal Order 1.
- 5** The contents of schedule 3 shall be inserted into schedule 2.0.1 of Principal Order 2.

**SCHEDULE 1 – No waiting at any time (Deletion from Schedule 2.01 of Principal Order 1)**

Road	Side	Description
Oak Tree Road	North-west	From a point 35m north-east of the north-eastern kerb line of Dimond Road south-westwards for a distance of 80m
Oak Tree Road	North-west	From its junction with Copsewood Road south-westwards for a distance of 70m
Oak Tree Road	South-east	From the north-eastern kerb line of Wellington Road north-eastwards to a point 50m south-west of the south-western kerb line of Copsewood Road

**SCHEDULE 2 – No waiting at any time (Addition to Schedule 2.01 of Principal Order 1)**

Road	Side	Description
Cherry Walk	North-west	For its entire length
Cherry Walk	South-east	From its south-western closed end to 2m north-east of the boundary between 2 Cherry Walk/ 5 Cherry Walk
Cherry Walk	South-east	From the south-west kerblines of Treeside Avenue south-westwards for 10m
Cherry Walk	South-western closed end	For its entire length
Chilcomb Road	North-east	From the south-eastern kerblines of Melchet Road south-eastwards for 6m
Chilcomb Road	South-west	From the south-eastern kerblines of Melchet Road south-eastwards for 10m
Grantham Road	North-west	From the north-eastern kerblines of Little Lances Hill north-eastwards for 10m
Gurney Road	South-west	From the north-western kerblines of Cherry Walk to the north-western kerblines of Gurney Road
Melchet Road	South-east	From 6m south-west of the south-western kerblines of Chilcomb Road to 6m north-east of the north-eastern kerblines of Chilcomb Road
Oaktree Road	North-west	From the boundary between 132 Oaktree Road/134 Oaktree Road south-westwards for 64m
Oaktree Road	North-west	From the south-western kerb line of Copsewood Road to 6m south-west of the boundary between 178 Oaktree Road/180 Oaktree Road
Oaktree Road	South-east	From the north-eastern kerblines of Wellington Road to 17m south-west of the south-western kerblines of Dimond Road
Oaktree Road	South-east	From the south-western kerb line of Copsewood Road to 10m south-west of the south-western kerblines of Dimond Road
Seymour Road	South-west	From the northern boundary of 7 Seymour Road to the southern boundary of 6 Seymour Road
Treeside Road	South-west	From the south-eastern kerblines of Cherry Walk south-eastwards for 10m
