



## **THE CITY OF SOUTHAMPTON (BANISTER ROAD) (LIDL DEVELOPMENT) ORDER 2020**

Southampton City Council in exercise of its powers under Sections 1, 2, 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

### **CITATION AND COMMENCEMENT**

- 1** This Order shall come into operation on 21<sup>st</sup> August 2020 and may be cited as The City of Southampton (Banister Road) (Lidl Development) Order 2020.

### **INTERPRETATION**

- 2** In this Order:
  - (i) "Principal Order" shall mean The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011.
  - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

### **AMENDMENTS**

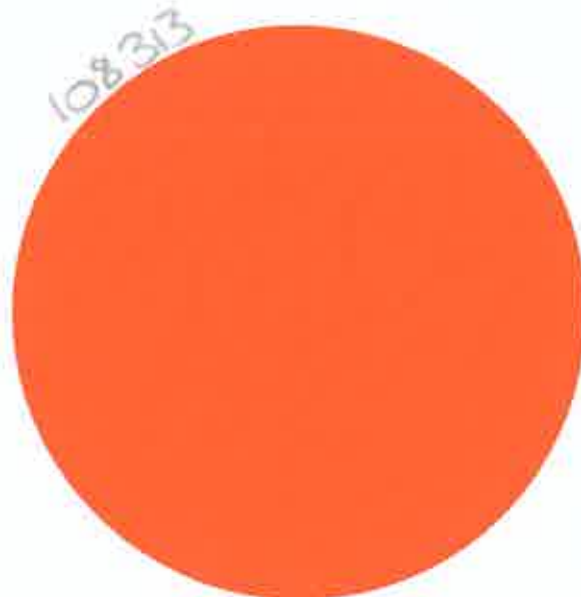
- 3** The contents of Schedule 1 shall be deleted from Schedule 2.01 of the Principal Order.

- 6** The contents of Schedule 4 shall be added to Schedule 6.10 of the Principal Order.

**Schedule 1 – No Waiting at Any Time (Deletion from Schedule 2.01)**

<b>Road</b>	<b>Side</b>	<b>Description</b>
Banister Road	West and North	From its junction with Archers Road to a point 20m east of its junction with Hulse Road
Banister Road	North	From a point 34m east of its junction with Hulse Road to its junction with The Avenue
Hulse Road	East	From a point 52m north of its junction with Banister Road northwards for 14m

**Schedule 2 – No Waiting at Any Time (Addition to Schedule 2.01)**

<b>Road</b>	<b>Side</b>	<b>Description</b>
Banister Road	North	From the northern kerbline of Archers Road northwards and north-eastwards to the western kerbline of The Avenue.

**Schedule 3 - Parking Places with 4 hour limit, 8am - 6pm, Monday to Friday (No Return Same Day)  
(Deletion from Schedule 6.10)**

<b>Road</b>	<b>Side</b>	<b>Description</b>
Hulse Road	East	From a point 20m north of its junction with Banister Road northwards for 32m
Hulse Road	East	From a point 66m north of its junction with Banister Road northwards for 37m
Banister Road	North	From a point 20m east of its junction with Hulse Road eastwards for 14m

**Schedule 4 - Parking Places with 4 hour limit, 8am - 6pm, Monday to Friday (No Return Same Day)  
(Addition to Schedule 6.10)**

<b>Road</b>	<b>Side</b>	<b>Description</b>
Hulse Road	East	From 20m north of the northern kerbline of Banister Road northwards for 83m.
