

THE CITY OF SOUTHAMPTON (WAITING RESTRICTIONS AMENDMENT 2) (PART A) ORDER 2021

Southampton City Council in exercise of its powers under Sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

1 This Order shall come into operation on 26th September 2022 and may be cited as The City of Southampton (Waiting Restrictions Amendment 2) (Part A) Order 2021.

INTERPRETATION

- 2 In this Order:
 - (i) "Principal Order 1" means the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011.
 - (ii) "Principal Order 2" means the City of Southampton (Residents Parking) (Zones 1-12 & 16) Order 2014.
 - (iii) "Principal Order 3" means the City of Southampton (City Centre) Order 2021.
 - (iv) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (v) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

- 3 The contents of Schedule 1 shall be deleted from Schedule 2.01 of Principal Order 1
- 4 The contents of Schedule 2 shall be added to Schedule 2.01 of Principal Order 1.
- 5 The contents of Schedule 3 shall be added to Schedule 3.0.1 of Principal Order 2.
- 6 The contents of Schedule 4 shall be added to Schedule 1 of Principal Order 3.
- 7 The contents of Schedule 5 shall be deleted from Schedule 2 of Principal Order 3.
- 8 The contents of Schedule 6 shall be added to Schedule 2 of Principal Order 3
