

THE CITY OF SOUTHAMPTON (EASTERN CYCLE ROUTE) (PHASE 1B) TRAFFIC REGULATION ORDER 2014

Southampton City Council in exercise of its powers under Sections 1, 2, 4, 45, 46 and Part IV of Schedule 17 of the Road Traffic Regulation Act 1984 as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 17 to the Act, hereby makes the following Order:

1 CITATION AND COMMENCEMENT

This Order shall come into operation on 17th March 2014 and may be cited as The City of Southampton (Eastern Cycle route) (Phase 1B) Traffic Regulation Order 2014.

2 INTERPRETATION

In this Order:

- (i) "Principal Order" shall mean The City of Southampton (First Controlled Zone) Traffic Regulation Order 2012, as amended.
- (ii) Except where otherwise stated any reference to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.


3 WAITING RESTRICTIONS
