

THE CITY OF SOUTHAMPTON (FIRST CONTROLLED ZONE) (AMENDMENT 30) ORDER 2019

Southampton City Council in exercise of its powers under Sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION AND COMMENCEMENT

1 This Order shall come into operation on 25th June 2021 and may be cited as The City of Southampton (First Controlled Zone) (Amendment 30) Order 2019.

INTERPRETATION

- 2 In this Order:
 - (i) "Principal Order" shall mean The City of Southampton (First Controlled Zone) Traffic Regulation Order 2012, as amended
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.


AMENDMENT OF SCHEDULES

Schedule 1 - No waiting at any time (Deletion from schedule 2.01)

Road	Side	Description
Elm Terrace	North-east	From the eastern kerb-line of Albert Road North to the eastern kerb-line of Endle Street
Chapel Road	South	From the western kerb-line of Albert Road north westwards for 20m
Anglesea Terrace	North	From its junction with Albert Road North for 20m in a westerly direction

Schedule 2 - No waiting at any time (Addition to schedule 2.01)

Road	Side	Description
Chapel Road	South	From the western kerbline of Albert Road North westwards for 9 metres
Anglesea Terrace	North	From the western kerbline of Albert Road North westwards for 14 metres
Elm Terrace	North	From the eastern kerbline of Albert Road North eastwards for 8 metres
Elm Terrace	North-east	From a point 30 metres east of Albert Road North south-eastwards to the eastern kerbline of Endle Street

Anglesea Terrace	North	From 15m east of its junction with Paget Street to 20m west of its junction with Albert Road North (max 5 bays. Parallel) (Zone A)	Α

Chapel Road	South	From 9 metres west of the western kerb-line of Albert Road North to a point 15 metres east of its junction with Paget Street (max 5 bays, Parallel) (Zone A)	A
Anglesea Terrace	North	From 15 metres east of its junction with Paget Street to 14 metres west of its junction with Albert Road North (max 6 bays, Parallel) (Zone A)	Α
