



**THE CITY OF SOUTHAMPTON
(FIRST CONTROLLED ZONE) (AMENDMENT 35) ORDER 2020**

Southampton City Council in exercise of its powers under Sections 1, 2, 32, 35, 45 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION AND COMMENCEMENT

- 1 This Order shall come into operation on 11th July 2020 and may be cited as The City of Southampton (First Controlled Zone) (Amendment 35) Order 2020.

INTERPRETATION

- 2 Except where otherwise stated, any reference in this order to an article or schedule shall be construed as a reference to that article or schedule in this order.
- 3 Any reference in this order to an enactment or order shall be construed as a reference to that enactment as amended by any subsequent enactments.
- 4 In this order "Principal Order" shall mean the City of Southampton (First Controlled Zone) Traffic Regulation Order 2012.

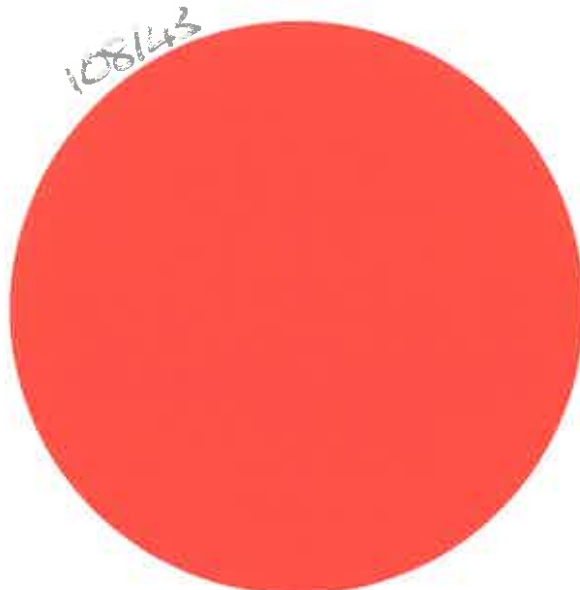
AMENDMENTS

College Place	West	From its junction with The Avenue to 16.5m south of the southern kerbline of The Avenue
College Place	West	From 36.5m south and south-west of the southern kerbline of The Avenue for 1m
College Place	West	From 53.5m south and south-west of the southern kerbline of The Avenue southwards to its junction with London Road

College Place	North-west	From 16.5m south of the southern kerbline of The Avenue south-westwards for 6m

College Place	North-west	From 22.5m south and south-west of the southern kerbline of The Avenue south-westwards for 14m (5 angled bays)	N/A
College Place	West	From 37.5m south and south-west of the southern kerbline of The Avenue southwards for 16m (4 angled bays, 1 parallel bay)	N/A
