



THE CITY OF SOUTHAMPTON (FIRST AVENUE) ORDER 2017

Southampton City Council (hereinafter called "the Council") in exercise of its powers under Sections 1, 2, 4, and Part IV of Schedule 9 of the Road Traffic Regulation Act, 1984, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

CITATION

- 1** This Order shall come into operation on 4th December 2017 and may be cited as The City of Southampton (First Avenue) Order 2017.

INTERPRETATION

- 2** In this Order:
 - (i) "Principal Order 1" shall mean the City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010, as amended.
 - (ii) "Principal Order 2" shall mean the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
 - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

MOVEMENT RESTRICTIONS

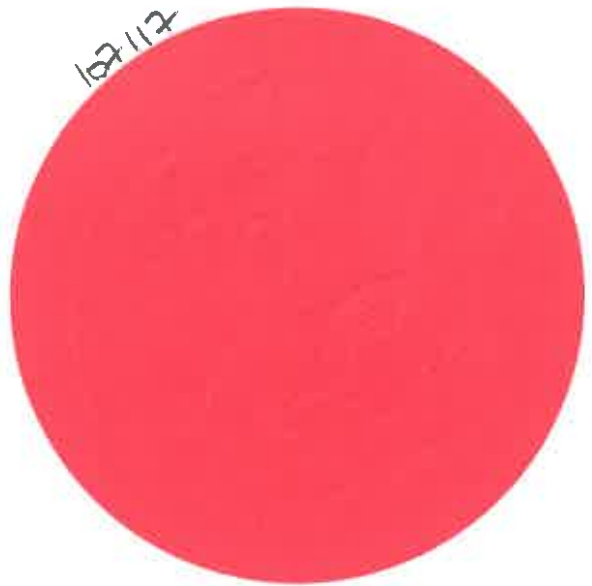
- 3** The contents of Schedule 1 shall be inserted into Schedule 11a of Principal Order 1
- 4** The contents of Schedule 2 shall be deleted from Schedule 4.17 of Principal Order 2
- 5** The contents of Schedule 3 shall be inserted into Schedule 2.01 of Principal Order 2
- 6** The contents of Schedule 4 shall be inserted into Schedule 3.01 of Principal Order 2

Schedule 1 (Two-way Cycle Lane – Addition – schedule 11a)

Road	Side	Description	Hours of Operation
First Avenue (Spine) (south-eastern arm)	South-east	From the south-western kerbline of Third Avenue south-westwards to the highway boundary	All

Schedule 2 (No Stopping at any Time – Deletion – schedule 4.17)

Road	Side	Description
First Avenue	Both	From the south-western kerb-line of Third Avenue southwards for 119m

Schedule 3 (No Waiting at Any Time – Addition – schedule 2.01)

Road	Side	Description
First Avenue (Spine) (south-eastern arm)	Both	From the south-western kerb-line of Third Avenue south-westwards to the highway boundary

Schedule 4 (No Loading at Any Time – Addition – schedule 3.01)

Road	Side	Description
First Avenue (Spine) (south-eastern arm)	Both	From the south-western kerb-line of Third Avenue south-westwards to the highway boundary
