

THE CITY OF SOUTHAMPTON (NEW ROAD) ORDER 2023

Southampton City Council in exercise of its powers under Sections 1, 2, 32, 35, 45, 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

1 This Order shall come into operation on 24th February 2024 and may be cited as The City of Southampton (New Road) Order 2023.

INTERPRETATION

- 2 In this Order:
 - (i) "Principal Order" means The City of Southampton (Moving Traffic Restrictions) Order 2022, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

- 3 The definition of "authorised vehicle" in Article 1.3 of the Principal Order shall be deleted and replaced with the following:
 - ""authorised vehicle" means any vehicle or class of vehicle specified in schedule B."
- 4 The contents of Schedule 1 shall be deleted from Schedule 18 of the Principal Order.
- 5 The contents of Schedule 2 shall be inserted into Schedule 18 of the Principal Order.
